-- James Drue Mcintyre J Arrest Narrative:

On 02/14/2025 at approximately 2030 hours I, Ofc. M. Beerbower (2259) responded to 700 Fleming St (Key West Library) regarding a report of a verbal disturbance. The call was a re-opened incident relating to two previous calls during the previous hour (KWPD CAD #250450232 and #250450237) in which a person was yelling and screaming at passers-by on the 700 block of Fleming St. and banging on the roof of a vehicle which was forced to drive away. The multiple callers described the person yelling and banging on the car as a black male, with a bald head, wearing yellow work style boots.

Upon arrival I saw James Drue Mcintyre Jr. (FL DL 06/06/1967) Who I recognized from a previous encounter. Mcintyre was standing over Jessica Anni Brazell (TX DL 12/21/1978), who was sitting on the wall in front of the library. As I was arriving, I could hear Mcintyre yelling at Brazell, but I could not discern the words he was saying. Mcintyre had a bald hair style and was wearing yellow work style boots. Once I made contact, Mcintyre provided the following:

He and Brazell had been involved in a lengthy verbal argument on the 700 block of Fleming St. over money issues. He knew that police would be "returning" because the argument was very loud and several passers by had threatened to call the police on him. He never touched Brazell but was angry over the money issues.

Sgt T. Peters spoke with Brazell who confirmed to her that the argument never turned physical but that she wanted to get away from Mcintyre because she was afraid of him. She also confirmed that she attempted to leave in a "Conch Connect' ride share vehicle, but Mcintyre had banged on the roof of the vehicle and told her to get out. That action resulted in the ride share driver telling her to get out so that she could drive away from Mcintyre.

At Brazell's request, she was placed into a KWPD vehicle for a courtesy ride to a safe residence away from Mcintyre. Brazell requested that officers grab her bags and her belongings from where they were sitting next to Mcintyre. Sgt T. Peters was attempting to gather Brazell's belongings and distinguish which property was hers and which was McIntyre's. While doing that, Mcintyre became agitated and began to move towards Sgt. Peters. Lt. J. Stockton took control of Mcintyre by grasping his arms to keep him from approaching Sgt. Peters. Mcintyre was given multiple verbal commands to stop moving towards Sgt Peters and to remain calm. Mcintyre began to jerk his arms in an apparent attempt to break Lt. Stocktons grip. At that point, I assisted Lt. Stockton in controlling McIntyre's arms and prevent him from approaching Sgt. Peters. Despite continued verbal commands for Mcintyre to stop jerking away, he quickly turned towards Lt. Stockton and used his chest to force his body against Lt. Stockton.

At that point I advised Mcintyre that he was under arrest and to put his hands behind his back. Mcintyre resisted efforts to place his hands behind his back despite being told that he was under arrest. I took Mcintyre to the ground in a controlled manner and with Lt. Stockton and Sgt. Peters assistance, we were able to place him in handcuffs. Mcintyre was at first apologetic for his actions stating that he meant no disrespect in jerking away and bumping into Lt. Stockton. However, once I began transporting Mcintyre to the Monroe County Detention Center, he became agitated again. He yelled and cursed at me the entire time he was in transport. Once we arrived at MCDC I escorted Mcintyre to the elevator to take him upstairs to intake. While we were in the elevator Mcintyre attempted to jerk away from me and yelled for me to take my hands off him. Mcintyre then attempted to turn toward me, forcing me to pin him against the corner of the elevator until we arrived on the first floor and an MSCO deputy assisted me in walking to a bench to sit him down. Mcintyre was then placed under the control of MCSO Detention deputies.

Given the above facts and evidence, I found probable cause to charge Mcintyre with the following:

Contrary to F.S.S. 877.03, James Drue Mcintyre Jr. did commits such acts as are of a nature to corrupt the public morals, or outrage the sense of public decency, or affect the peace and quiet of persons who may witness them, or engaged in such conduct as to constitute a breach of the peace or disorderly conduct by yelling and screaming obscenities at Jessica Brazell in public and by banging on the roof of a ride share vehicle causing multiple people who witnessed his actions to call police for assistance.

One (1) count of Resisting officer without violence to his or her person.

Contrary to F.S.S. 843.02, James Drue Mcintyre Jr. did resist, obstruct, or oppose KWPD officers in the lawful execution of their legal duty, without offering or doing violence to them by reusing to obey verbal commands not to approach and by physically resisting efforts for officers to take him into custody by jerking his arms away and bumping into them in an attempt to break free.

My AXON BWC was activated during the encounter on Fleming St. and during escort in the elevator at the MCDC and uploaded to Evidence.com.
