A RESOLUTION OF THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY (CRA), RATIFYING AN EMERGENCY PROCUREMENT APPROVED BY THE CITY MANAGER IN EXCESS OF \$20,000 AS ALLOWED UNDER SECTION 2-797(2) OF CITY'S CODE OF ORDINANCES, FOR THE PROCUREMENT OF SERVICES TO RELOCATE 61 PALM TREES FROM CONCH HARBOR TO KEY WEST BIGHT, SAID PROCUREMENT IN THE AMOUNT OF \$33,002.25 TO ECOSCAPES; AUTHORIZING NECESSARY BUDGET TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the owners of Conch Harbor are authorized to remove landscaping, including up to 61 palms trees to commence new construction on Conch Harbor/West Marine property; and

WHEREAS, the City negotiated with Conch Harbor to acquire the palm trees at no cost, to be transplanted at the City's expense, to locations within the Key West Bight; and

WHEREAS, the City Manager acted without delay, utilizing emergency powers authorized under Section 2-797(2) of the City's Code of Ordinances, to procure services to transplant the palm trees promptly; and

WHEREAS, Section 2-797(2) of the City's Code of Ordinances requires the City Commission to ratify such emergency purchases at its next scheduled meeting.

NOW, THEREFORE, BE IT RESOLVED BY THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY, AS FOLLOWS:

Section 1: The City Commission sitting as the CRA, in accordance with Section 2-797(2) of the City of Key West Code of Ordinances, hereby ratifies the City Manager's emergency authorization for the procurement in the amount of \$33,002.25 from Ecoscapes, for the relocation of 61 palm trees from Conch Harbor to Key West Bight.

Section 2: That necessary budget transfers are authorized.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Agency.
