A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE OPTION TO RENEW THE ATTACHED "AGREEMENT BETWEEN THE CITY OF KEY WEST AND LANGTON ASSOCIATES, INC" FOR GRANT WRITING AND GRANT ADMINISTRATION SERVICES FOR AN ADDITIONAL TWO YEARS TO JANUARY 31, 2028 IN ACCORDANCE WITH ARTICLE 4 TERM OF AGREEMENT; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS AND ANY NECESSARY BUDGET AMENDMENTS AND TRANSFERS, UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution 24-124, the City Commission accepted the negotiated and executed agreement between the City of Key West and Langton Associates, Inc. for grant writing and grant administration services for a period of three (3) years from the effective date of the agreement with the option of a two (2) year renewal for a total of five (5) years; and

WHEREAS, the effective date of the agreement is February 1, 2023; and

WHEREAS, in Article 4 Term of Agreement, the Agreement may be renewed for an additional two (2) years at the discretion of the City; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the option to renew the attached "Agreement Between the City of Key West and Langton Associates, Inc." for grant writing and grant administration services for an additional two (2) years to January 31, 2028 is hereby approved.

Section 2: That the City Manager is authorized to execute any necessary documents and any necessary budget amendments and transfers, upon advice and consent of the City Attorney. That expenses are budgeted in Expense Account 001-1900-519-3100.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
