A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RATIFYING AN EMERGENCY PROCUREMENT APPROVED BY THE CITY MANAGER IN EXCESS OF \$20,000 AS ALLOWED UNDER SECTION 2-797(2) OF CITY'S CODE OF ORDINANCES, FOR THE PROCUREMENT FROM XYLEM WATER SOLUTIONS USA OF TWO PUMP STATION REPAIR KITS AND ONE IMPELLER IN AN AMOUNT NOT TO EXCEED \$24,091.00; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in recent months both pump station repair kits that are kept in stock for the City were used, leaving the City without the ability to rebuild pumps at stations B and C, if they were to fail in the immediate future; and

WHEREAS, the City Manager acted without delay, using emergency powers authorized under Section 2-797(2) of the City's Code of Ordinances, to authorize an emergency procurement in the amount of \$24,091.00 to ensure that necessary repair supplies are re-stocked immediately; and

WHEREAS, Section 2-797(2) of the City's Code of Ordinances requires the City Commission to ratify such emergency purchases at its next scheduled meeting.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: The City Commission, in accordance with Section 2-797(2) of the City of Key West Code of Ordinances, hereby ratifies an emergency procurement in the total amount of \$24,091.00 to Xylem Water Solutions USA for two pump station repair kits and one impeller.

Section 2: That adequate funds are budgeted for this equipment in FY 15/16 account 401-3504-535-4600.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
