A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING PURSUANT TO CODE OF ORDINANCES SECTIONS 2-797(3)(b), WAIVER OF FORMAL BID PROCEDURES, 2-797(4)(b), BEST INTERESTS OF THE CITY AND 2-844 BRAND NAME SPECIFICATIONS, THE PURCHASE OF EMC DATA BACKUP COMPONENTS FROM GOVCONNECTION, INC. FOR KEY WEST CITY HALL AND OTHER CITY LOCATIONS, IN AN AMOUNT NOT TO EXCEED \$43,029.26; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 2-796 of the Code of Ordinances requires competitive bidding for purchases or services in excess of \$20,000.00; and

WHEREAS, EMC brand name components comprise the backbone of the City's electronic media storage system, and City management, in conjunction with the purchasing agent, has determined that a transition to different brand name would be cost prohibitive; and

WHEREAS, City staff obtained price quotes from at least three vendors, and determined that the quote provided by GovConnection, Inc. was the lowest price; and

WHEREAS, the City Manager has determined that the purchase EMC data backup components for the Key West City Hall Data Center, and other city locations, as described in the attached price quote, is in the best interests of the City pursuant to section 2-797(4)(b) of the Code of Ordinances; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase EMC Data Domain Backup Solution equipment, as described in the attached proposal from GovConnection, Inc. in an amount not to exceed \$43,029.26 is hereby approved, pursuant to Section 2-797(3)(b), waiver of formal bid procedures, Section 2-797(4)(b), best interests of the City, and Section 2-844, brand name specifications, of the Code of Ordinances.

Section 2: That funding for this purchase is budgeted as part of the City Hall Data Center, Project Code GN1302 for FY 16-17.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
