CITY OF KEY WEST'S OBJECTION TO APPELLANT'S NOTICE OF APPEAL

- 1. The Appellant, Monroe Glass & Mirror submitted an application to HARC to remove and replace windows on the front façade of a storefront within the Kress Building; a significant contributing structure in the historic district.
- 2. The application was duly denied.
- 3. The Appellant filed a letter that the undersigned will consider a Notice of Appeal that was received by the City of Key West on April 4, 2011.
- 4. Sec. 90-431(1)(a) mandates that the City Clerk receive said notice within ten (10) days of the decision.
- 5. The Notice was received 12 days after the decision and therefore untimely.
