A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING WECYCLE, INC. AND THE KEY WEST ART AND HISTORICAL SOCIETY, INC. TO CONDUCT THE ANNUAL ZOMBIE BIKE RIDE EVENT STARTING AT FORT EAST MARTELLO AND ENDING ON THE 100, 200 & 300 BLOCKS OF DUVAL STREET ON SUNDAY, OCTOBER 19, 2025, FROM 6:00 P.M. TO 11:59 P.M.; PURSUANT TO THE TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE CLOSURE OF THE 100 , 200 & 300 BLOCKS OF DUVAL STREET ON SUNDAY, OCTOBER 19, 2025 FROM 8:00 P.M. TO 11:59 P.M; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, WeCycle, Inc. wishes to conduct the annual "Zombie Bike Ride" during the hours of 6:00 p.m. to 11:59 p.m. on Sunday, October 19, 2025;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

SECTION 1. That in Resolution 19-174, the City Commission directed the City Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law."

SECTION 2. "That the vendor/lessee/licensee acknowledges the City's concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor

therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and "To go" packages for food or products sold on any property leased from the City."

SECTION 3. That WeCycle, Inc. is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the time and place as herein described; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; and that the organization meets the terms and conditions set forth by the City Manager.

SECTION 4. That WeCycle, Inc. is hereby granted permission for the closure of the 100, 200 & 300 blocks of Duval Street on the date and during the hours stated above for the ending of the ride.

SECTION 5. That WeCycle, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for everyone (1) trash barrels will be used and that they will be placed side by side.

SECTION 6. That WeCycle, Inc. pledges that proceeds will benefit the Key West Art and Historical Society to further art and historical education in Key West.

SECTION 7. That WeCycle, Inc. acknowledges that they are responsible for payment to the Key West Police Department, the Key West Fire Department and Community Services.

SECTION 8. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officers and Clerk of the Commission.
