**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING AND AUTHORIZING EXECUTION OF THE ATTACHED AGREEMENT BETWEEN THE CITY OF KEY WEST AND THE SUNRISE ROTARY FOUNDATION OF KEY WEST, INC. FOR CHARITY MOTORCYCLE BIKE WEEK ON SEPTEMBER 18 & 19, 2015; AUTHORIZING THE CLOSURE OF DUVAL STREET FROM ANGELA STREET TO FRONT STREET ON FRIDAY, SEPTEMBER 18, 2015 AND SATURDAY, SEPTEMBER 19, 2015 FROM 10:00 A.M. TO 12:00 MIDNIGHT; ALL CROSS STREETS SHALL REMAIN OPEN EXCEPT GREENE STREET BETWEEN WHITEHEAD TO ANN STREET AND CAROLINE STREET FROM WHITEHEAD TO SIMONTON STREET; AUTHORIZING THE SALE & CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE BARRICADED AREA OF THE EVENT; GRANTING AN EXEMPTION FROM THE NOISE CONTROL ORDINANCE PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES DURING THE EVENT; PROVIDING FOR AN EFFECTIVE DATE**

**BE IT RESOLVED** by the City Commission of the City of Key West Florida, as follows:

**Section 1.** That the attached agreement between the City of Key West and the Sunrise Rotary Foundation of Key West, Inc. is hereby approved. The City Manager is hereby authorized to execute said agreement on behalf of the City of Key West, and the City Clerk is hereby authorized to attest to his signature and affix the Seal of the City thereto.

**Section 2.** That all neighboring property owners and/or tenants shall be notified of the event and the date, time.

**Section 3.** That approval of this resolution is given upon the condition that the event organizers will make best efforts to alert the participants to abide by City and State noise regulations with respect to motorcycle mufflers; and that the City and event organizers will work

together to post signs leading into Key West to alert the participants about the noise concern.

**Section 4.** That pursuant to the City of Key West Code of Ordinances, Section 18-86, the consumption of alcoholic beverages is permitted within the barricaded areas of the Event, pursuant to the terms and conditions in the attached agreement.

**Section 5.** That the Sunrise Rotary Foundation of Key West, Inc. is hereby granted an exemption from the sound control ordinance under section 6-86 of Key West Code of Ordinance for an event that will take place at the place and time as herein described.

**Section 6.** That the Key West Sunrise Rotary Club will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

**Section 7.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
