ACTION STATEMENT:

Grant writers, Langton Associates, Inc. and IN REM Solutions, Inc., will present the Grants Needs Assessment and Strategic Grants Plan.

BACKGROUND:

At a meeting held on March 5, 2013, the City Commission selected Langton Associates & IN REM Solutions as the City's professional grant writers as a result of a competitive RFQ (#002-13).

A Contract for services began the next day on March 6, 2013.

As part of the Grant Needs Assessment process on-site interviews were conducted with individual City Commissioners and City Staff from every Department during the week of April 8-12, 2013.

Over the following months a comprehensive list of needs was created reflecting all the needs and interests of the City.

The next step was extensive research by two (2) Research Specialists from Langton Associates & IN REM Solutions to attempt to identify possible grant matches for each and every City need. The result of this effort is the **Grant Research List**.
