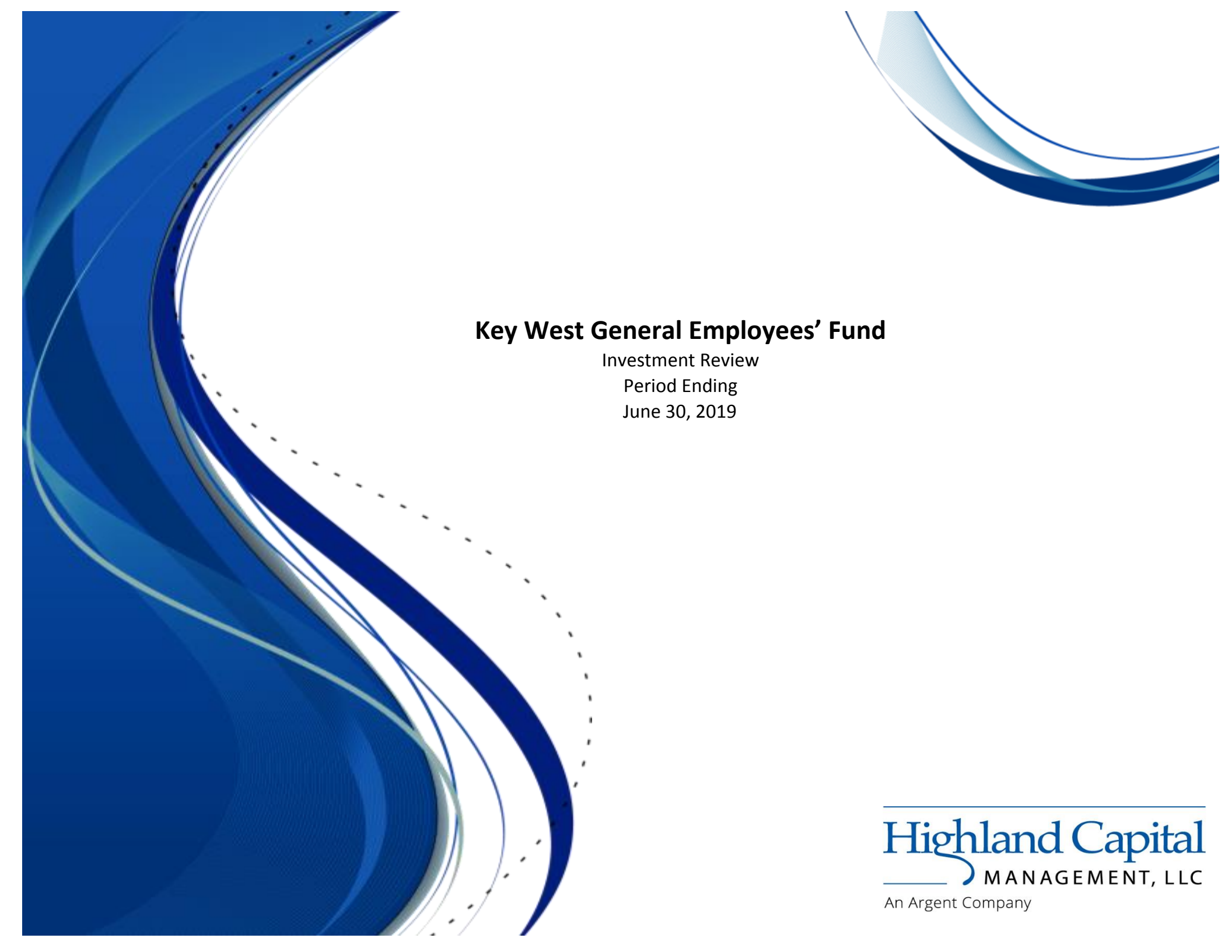

2Q19 Equity Commentary

The second quarter of 2019 was a bit of a roller coaster. The market moved higher in April adding to the strong gains of Q1 as earnings came in better than expected, only to stumble 6.6% in May when trade war worries escalated. June saw a strong rebound with the S&P gaining 7% as trade tensions eased and the Fed signaled that rate cuts might lie ahead. For the quarter the S&P gained 4.3% and is now up 18.5% YTD. The strong gains were noteworthy as this was the best month of June for the S&P since 1955, and the best first half of a year for the market since 1997. The market has now surpassed the highs of last October, and more than fully erased the steep decline in Q4 of 2018. At just over 10 years now (124 months to be precise) this is the longest running bull market since 1928, and is now the second highest in terms of total return with a gain of 335%.

While the market has performed very nicely in 2019, the impact of tariffs and talk of trade wars has had a negative impact on consumer confidence and business confidence. The University of Michigan Consumer Sentiment Index fell in June to 97.9 from 100 in May. Consumer's outlook on future growth and employment has been tempered by the uncertainty created from tariffs. The same is true in the corporate world, as the Duke CFO Survey shows that capital spending expectations for the next 12 months have moderated from an increase of 8.2% in March, to just a 3.4% increase as of June. This is important as capital spending could be another leg of growth that could extend this economic expansion. Perhaps nowhere has the impact of tariffs been more pronounced than in the manufacturing sector. The June US Manufacturing ISM report showed the manufacturing sector softening for the third straight month.

Readings above 50 indicate expansion and the June reading was 51.7, but this is down from 60.8 in August of 2018, and 56.6 as recently as January of 2019. Both new orders and backlogs are showing signs of weakness, with backlogs contracting for the last two months. The Global Manufacturing PMI is also weakening as it has fallen into contraction territory and is at its lowest level since February of 2016. This does not mean that recession is imminent, but it does confirm that growth has slowed both in the US and the rest of the world, and clearly bears watching. Q1 2019 GDP did surprise to the upside coming in at 3.1%, but we would anticipate that US growth for the balance of 2019 is closer to 2%, with Q2 likely being the weakest as Q1 probably pulled forward some demand trying to get ahead of impending tariffs.

Second Quarter Market Recap:

Similar to Q1, the top performing groups in Q2 also had more of a "risk on" character. Financials were the best performing group gaining 8%. Both Citigroup and Keycorp gained over 13% in the quarter. Broadly speaking, the less interest sensitive areas of the group such as multi-line insurance, financial exchanges, and consumer finance performed best, while the money center and regional banks slightly lagged as interest rates fell. Materials and Technology both gained over 6% in Q2, with Industrial Gases and Gold leading in Materials, while software services within Tech continued their strong gains (i.e. Microsoft +14%).

Second Quarter Market Recap Cont.:

Gold likely benefited from either real or perceived currency manipulation as central banks move to a more accommodative stance, along with the geopolitical tensions emanating from Iran and the Straits of Hormuz. With trade uncertainty, rising international tensions, and slowing global growth you might have anticipated that defensive sectors would have performed better. However, this was not the case as Consumer Staples, Utilities, and Healthcare all performed below the market in the quarter. Both Staples and Utilities are trading above their 5 and 10 year valuation multiple averages, so perhaps the market is recognizing that their defensiveness is coming at a steep price. The lag in Healthcare is more easily explained by the bipartisan support to lower drug prices, along with rhetoric of "Medicare for All" that would drastically change the healthcare landscape. Our managed care holdings (Cigna, Humana, CVS) were in a range of -2% to +2% in the quarter. The trend of growth stocks outperforming value stocks, as well as large caps beating small caps continued in Q2. If the Fed cuts rates in the coming months we would expect that trend to persist.

Outlook:

With the best first half in the books since the late 90's and the market hitting new highs we should feel exuberant at this point. But in keeping with the character of this being the most unloved bull market in history, we find ourselves looking cautiously at the second half of the year.

Outlook Cont.:

We are concerned about tariffs, a slowing US and global economy, political division, geopolitical hotspots, and a still unresolved Brexit. On the positive side central banks around the world are skewed to easing. Just 6 months ago the consensus in the US was that the Fed would raise rates four times in 2019. Now, that same consensus is for 2 rate cuts in 2019. The 3 month change in M2 money supply growth is at the hottest pace since mid-2016, and this is usually a positive for risky assets such as stocks. Investors are not euphoric. The first half of 2019 saw more money flow into bond ETF's (\$74 billion), than into stock ETF's (\$41 billion). With global trade flows and PMI's weakening, our opinion is that the market is already discounting central bank easing and the possibility that a trade deal gets done. The market is likely to suffer some drawdown if the Fed does not ease as significantly as the market seems to be expecting. Another more fundamental concern for the market is earnings growth, or the lack thereof. Q1 2019 earnings posted a decline of -0.3%. The trend for Q2 is worsening as the consensus estimate is for earnings to decline 2.6%, making this officially an "earnings recession", and the first time since Q1/Q2 2016 that we have had back to back down quarters in earnings. So far 87 companies have issued negative earnings guidance for Q2 2019, which is the highest number since Q2 of 2006. In the near term however, the central bankers are likely to trump fundamentals with all eyes on their next move, or the parsing of press releases for hints at policy changes.

Outlook Cont.:

So what does this mean for your portfolios? From a portfolio management perspective this will require us to be nimble. Should the slowdown continue and the central bankers not ease as aggressively, it would require us to adopt a more defensive stance. If easing does occur and some form of trade deal is approved, then growth in 2020 should improve, and our current portfolio positioning which favors more cyclical areas of the market should continue to be rewarded.

Valuation:

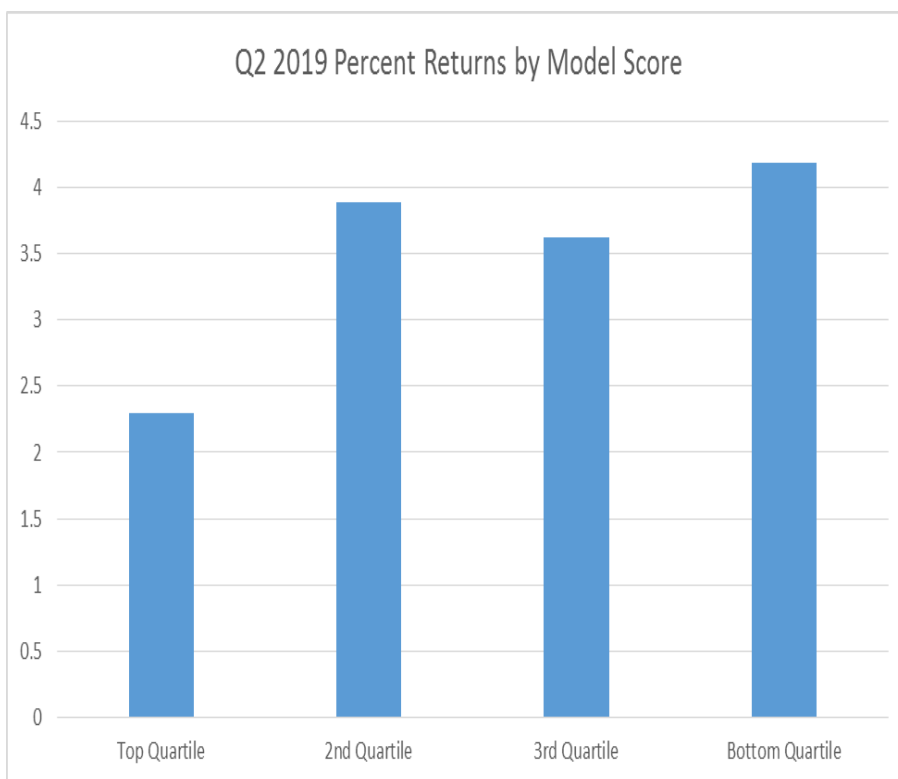
The market is currently selling at 16.6X forward earnings, which is above the five year average of 16.5X and the 10 year average of 14.8X. We continue to see the market as being close to fully valued. Yes, the market can support a higher multiple in periods of low inflation and declining interest rates, and inflation continues to stay stubbornly below the Fed's target of 2%. Yet, we don't see the earnings multiple expanding in the current environment of flat to slightly down earnings for the next couple of quarters. There is also the potential for some pressure on profit margins as wages rise and tariffs bite, however, with the peak in job growth now behind us that could begin to ease. We suspect that the market will move sideways over the next few months as both political and monetary policy do their work. If this is the case, then earnings growth should resume in Q4, and the market will begin to price based off on an improving

2Q19 Large Cap Value Equity Commentary

Returns for the Large Cap Value portfolios were largely in line with the index despite the volatility. Nonetheless, the average stock in the Russell 1000 Value index advanced a healthy 3.50% percent during the quarter. As we show in the chart, the value model wasn't as predictive of outperformance during the quarter, with the lowest ranked stocks outperforming the top ranked.

This performance pattern is a further reaffirmation of the Value/Growth disconnect we've been tracking for our clients. As the next chart shows, the relative outperformance of Growth relative to Value continued during the quarter.

Given the relative outperformance of growth late in this cycle, Value managers can be tempted to “sneak” a bit of alpha into their returns, by letting the amount they are willing to pay for companies increase, measured by P/E or P/BV. Historically, this risk taking has been safer at the bottom of business cycles, when companies are emerging from negative growth profit recessions and valuations can be stretched as profits grow into the prices. When done at the top of cycles, it has typically been a short term performance pressure that ends badly for clients who find themselves overexposed to expensive growth style investing at the top.

Russell Company rebalances their indexes each July to reflect price changes. Below is the old and new Index weightings for the Large Cap Value Index.

As I’ve highlighted above, the ytd price appreciation in the Health Care and especially the Technology sectors have forced them out of the value index and into the growth. The consequence being that the growth index becomes ever more concentrated in the Tech sector as the Value index becomes more diversified with the exception of Financials.

Looking forward, the performance story is shaping up to be a comparison of technology and financials as the economy moves increasingly toward the end of the cycle. As always our modelling process seeks to uncover those investments combining the best mix of profits and valuation, and should serve us as we inch closer to the end of the cycle.

2Q19 Large Cap Growth Equity Commentary

The 2nd quarter of the year yielded more volatility but not from the expected sources. The inverted yield curve already had markets on edge but initial news began to alleviate some of those concerns as firms reported solid numbers with forecasts better than expectations. The surprise escalation in the US-China trade war shocked markets as sentiment was overwhelmingly towards a settlement. Markets kept hope of a quick truce to deescalate the trade war as large sell-offs would almost recover by the end of the trading day but the market ultimately realized no quick truce was forthcoming and the cycle was broken. Markets began trending upwards in June with a boost at the end with news of Trump and Xi. For the quarter, the Russell 1000 Large Cap Growth Index returned 4.64% while the strategy returned 3.98%, underperforming by 66 bps. The model began the quarter well, outperforming the benchmark for April but the sudden escalation in the US-China trade war began a downward trend in the model. Growth expectations, fundamentals and valuations were thrown for a loop as the US-China trade war overhang injected greater uncertainty about the state of the economy and growth expectations.

Performance Attribution

Value factors continued their underperformance although they have showed signs of life; stocks with greater exposure to China became cheaper and the positive news provided some lift to Value. Growth factors underperformed as well as the tariff overhang increased uncertainty on growth from companies. Technical factors have continued to perform well with only momentum performing poorly for the quarter as volatility in the markets increased.

The best performing sectors last quarter were Utilities (+10%), Financial Services (+9%) and Materials & Processing (+8%). The Utilities sector in the Growth index is skewed as it only contains 2 stocks. The only sector with negative performance for the quarter was Energy (-3%) as crude oil prices also fell for the quarter. The Health Care sector was flat for the quarter as political news generated uncertainty into the direction of Health Care.

Outlook

While a resolution to the US-China trade war is far from complete, the G-20 meeting and resultant truce was a catalyst for upward momentum in the stock markets. Expected interest rate cuts by the FOMC have added further fuel to the fire in lifting stocks. There is worry about the state of the US economy as Global growth rates predictions become more muted. The FOMC have expressed an accommodative and dovish stance in cutting interest rates to add stimulus to the US economy based on the macro-economic data. There is also still sentiment towards an eventual agreement between China and the US, although this is viewed with less probability than at the end of the last quarter; also, the timing of any deal is always difficult to ascertain. These factors should parlay into a boost for the economy and stocks markets and expectations are for stocks to continue their trend higher.

2Q19 Fixed Income Portfolio Manager Commentary

On June 19th, the Federal Reserve indicated they are closer to cutting short term interest rates for the first time in more than a decade. Chairman Powell held the key interest rate stable; however they noted “muted inflation pressures” and “will act as appropriate to sustain the expansion.” The vote within the Fed was not unanimous, St. Louis Fed President James Bullard voted in favor of a quarter-point rate reduction. This was the first dissent under Chairman Powell’s tenure. The Federal Reserve didn’t specify when it would cut interest rates, but nearly half of Fed leaders now predict rates will fall by the end of 2019, a significant change from March when none of the 17 Fed policymakers anticipated a cut this year. The Federal Reserve also conceded that inflation is “running below” the Fed’s 2% objective. Forecasted headline inflation was reduced to 1.5% from March’s forecast of 1.8%. The decline in interest rates in 2019 has been related to weaker growth both in the US/abroad and the persistent low levels of inflation. Neel Kashkari, the Minneapolis Federal Reserve President (a non-voting member), advocated for a 50 basis point rate cut in June in order to re-anchor inflation expectations. Chairman Powell isn’t the only central banker concerned about slowing growth and inflation. In June, European Central Bank President Mario Draghi stated they could cut interest rates again or provide further asset purchases if inflation doesn’t reach its target. If economic conditions deteriorate, the ECB would announce further stimulus. These dovish comments from President Draghi pressured European interest rates to historical lows.

The world now has \$13 trillion of debt with yields below zero percent and 40% of global bonds yield less than 1%. The vast majority of European sovereign debt yields well below US rates. Market sentiment and expectations turned swiftly over the past six months, very prominent Wall Street banks were forecasting in December the Fed to raise interest rates four times in 2019. Those same economists are predicting the Fed to reduce interest rates twice before year end. Escalating trade tensions could force the Fed to move aggressively in July.

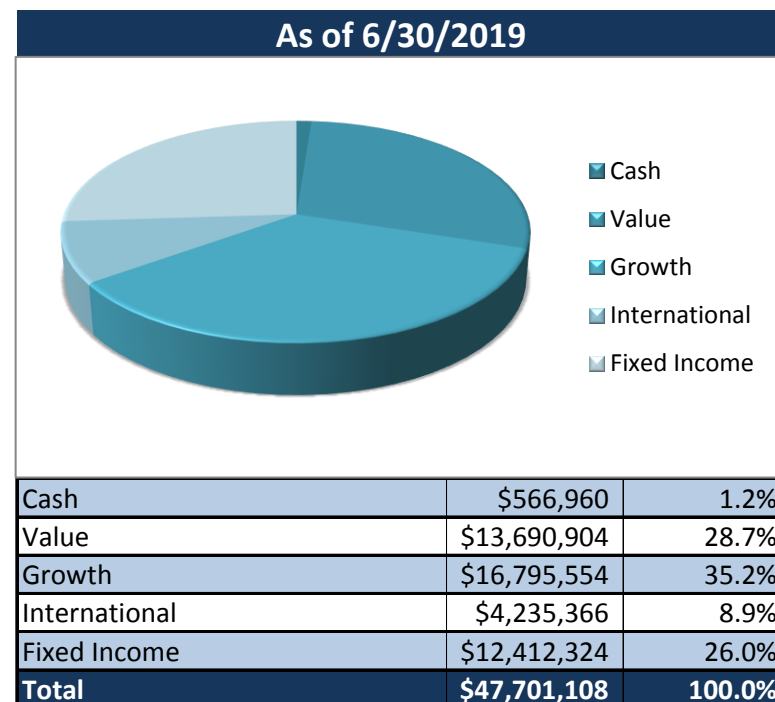
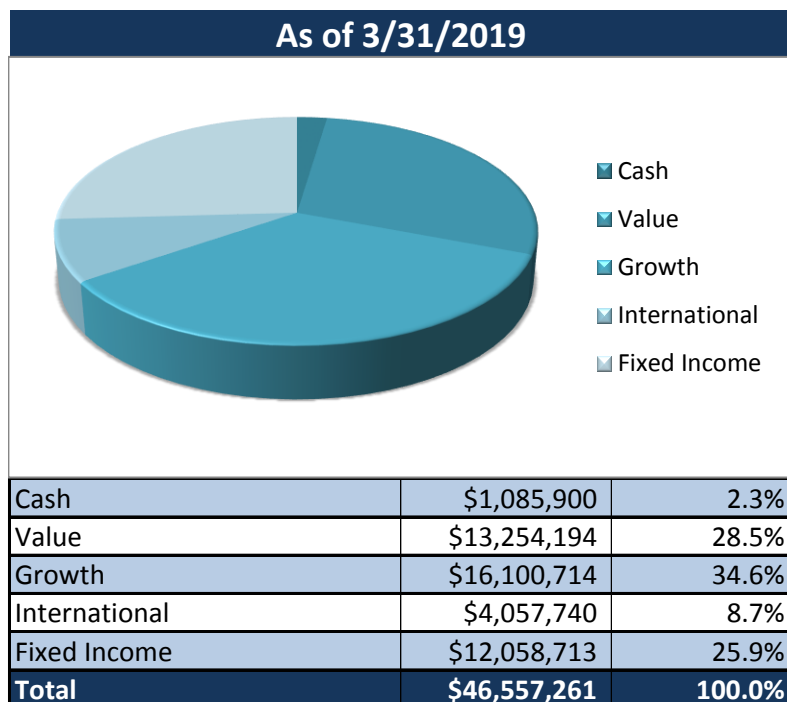

The same investment trends during the first quarter of this year played out during the second quarter. Investors wanted to be overweight risky and longer duration securities as corporate spreads tightened at the same time interest rates declined. The Bloomberg Barclays Aggregate was up +3.08% during the quarter and now 6.11% year to date. This is somewhat remarkable as the yield to maturity on the index is only 2.5%. The Bloomberg Barclays US Intermediate Gov/Credit index was up +2.59% and is now up 4.97% year to date. To sum up performance during the quarter, low quality and longer maturity securities outperformed again. We are forecasting long term interest rates will be stable until we see coordinated global economic expansion leading to inflation in excess of 2%.

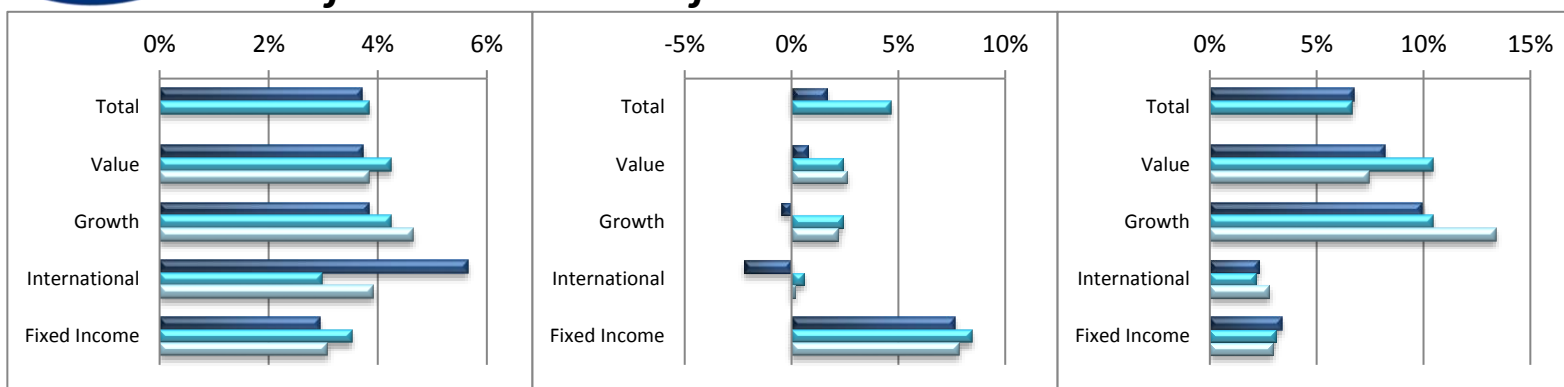

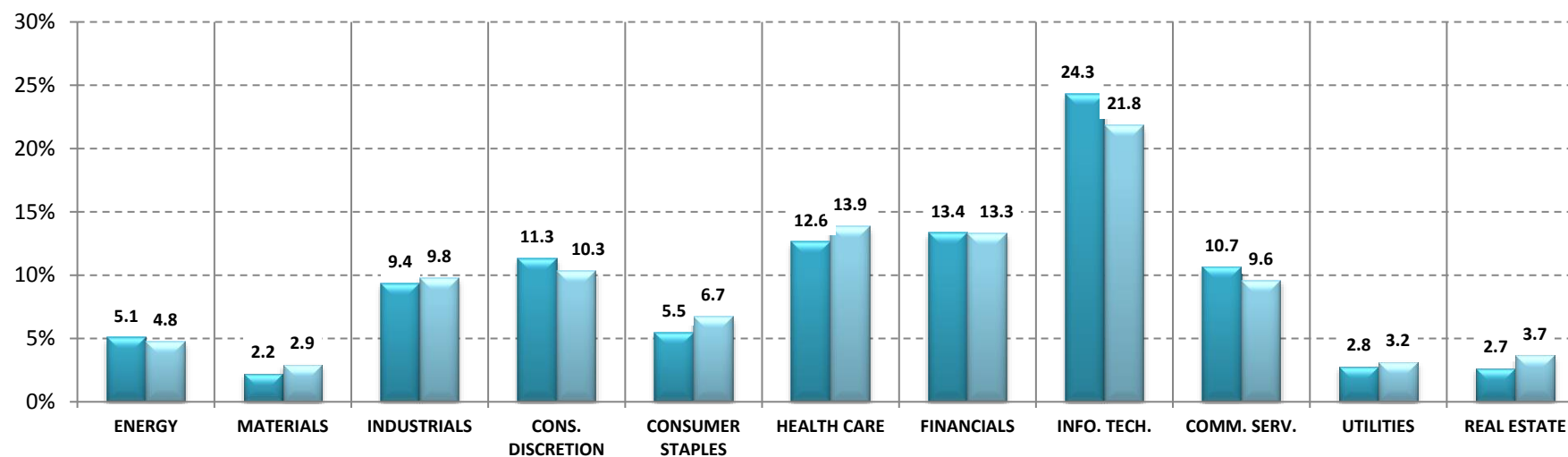

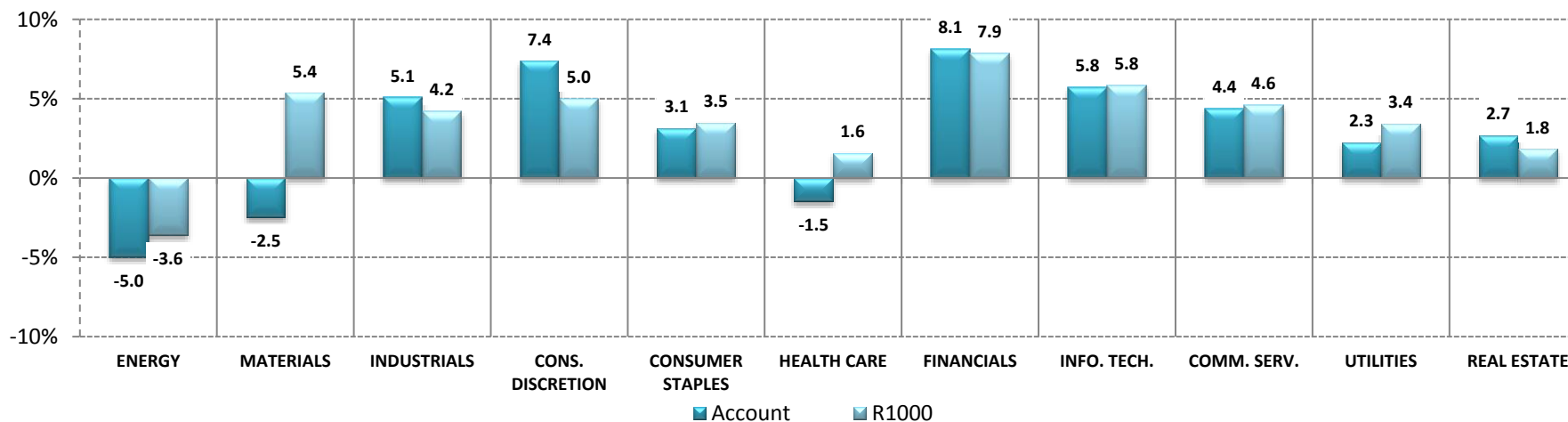

Domestic Equity Sector Allocation vs. R1000

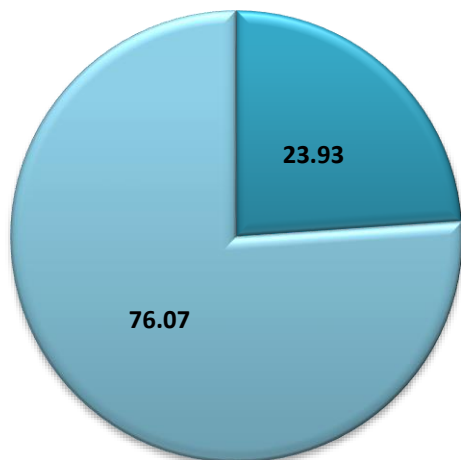


Domestic Equity Quarterly Sector Returns vs. R1000

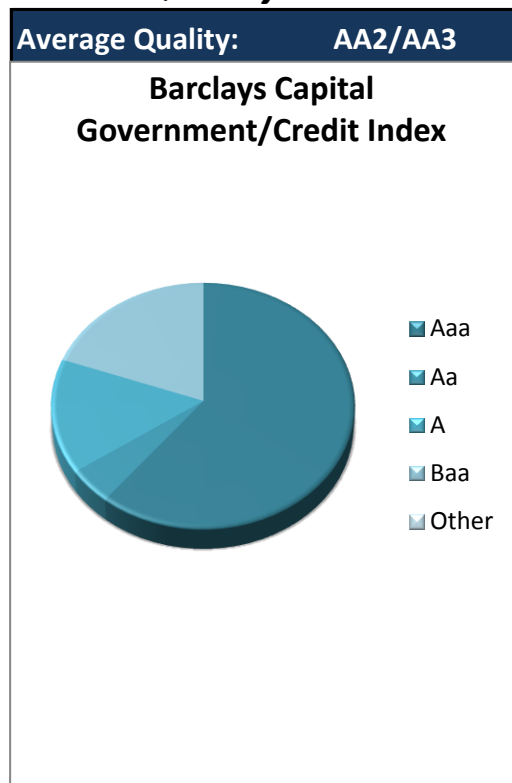
Fixed Income Sector Allocation



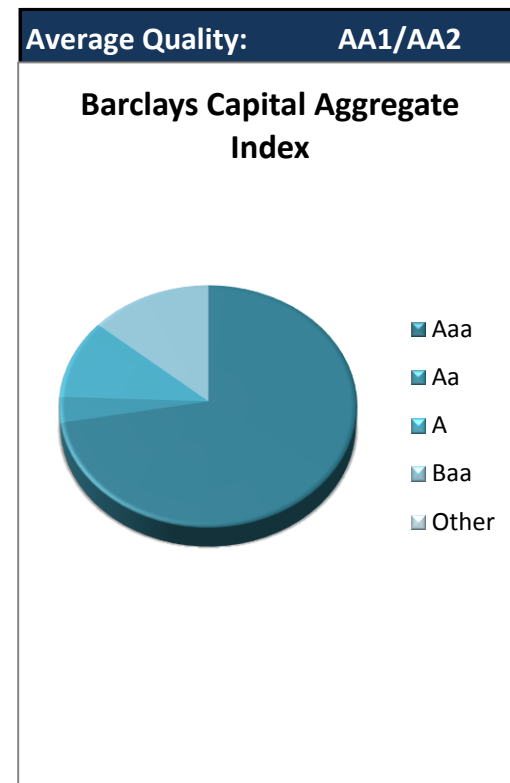

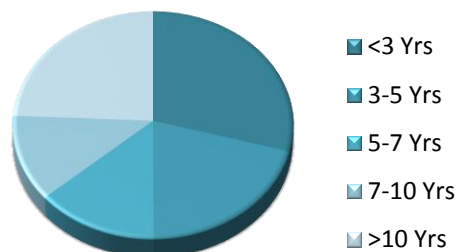

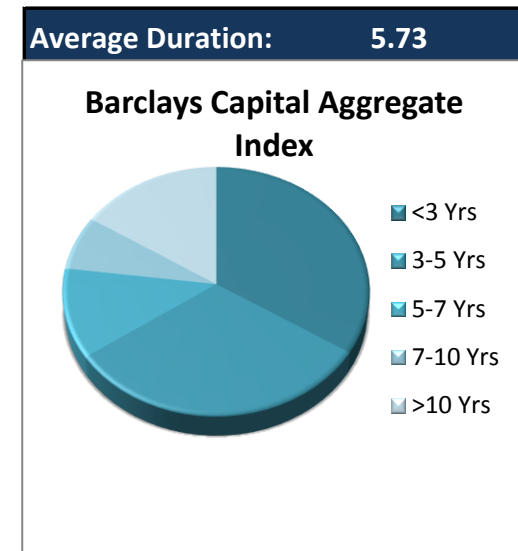
Duration Allocation



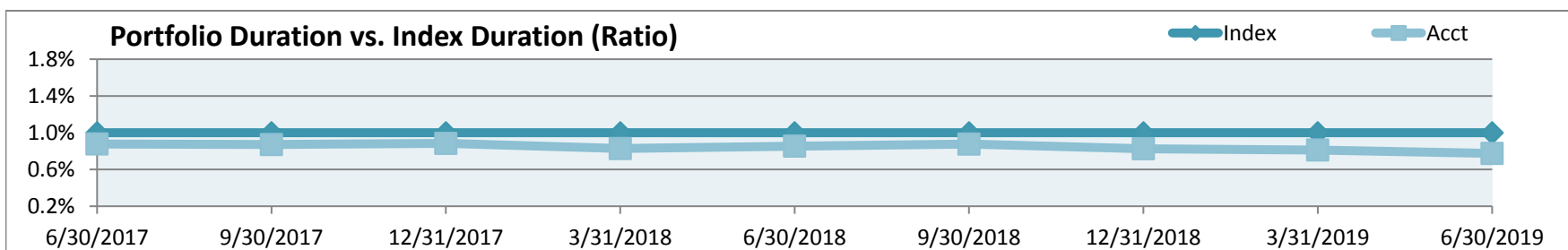
