A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF TEN (10) CALE MP104 COMPACT MULTI-SPACE PAY AND DISPLAY PARKING STATIONS IN ACCORDANCE WITH CITY CODE SECTION 2-844, (CONCURRENTLY WITH ONE (1) CALE PARKING STATION FOR THE KEY WEST BIGHT, APPROVED IN CRA RESOLUTION NO. 13-\_\_\_\_\_) IN AN AMOUNT NOT TO EXCEED \$97,900.00 INSTALLED, PURSUANT TO CITY CODE SECTION 2-797(1); PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the approved Parking Budget for 2012-13 includes an appropriation for the purchase of ten (10) pay and display parking stations at a total cost of \$89,000.00; and

WHEREAS, the Key West Bight approved 2012-13 budget includes an appropriation for the purchase of one pay and display parking station at a total cost of \$8,900.00; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase and installation of ten Cale MP104 Compact Multi-Space Pay and Display Parking Stations, from Cale America, Inc. in accordance with City Code section 2-844, is hereby authorized pursuant to Key West City Code of Ordinances 2-797(1).

Section 2: That this purchase will be made in conjunction with the purchase of one additional Cale multi-space parking

station (making a total of eleven), using funds from the Key West Bight budget, as recorded in concurrent CRA resolution No. 13-\_\_\_\_\_.

Section 3: The purchase of Cale parking stations for the City and Key West Bight combined is authorized in an amount not to exceed \$97,900.00

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
