CITY COMMISSION MEETING

TUESDAY, APRIL 3, 2012

A regular meeting of the City Commission of the City of Key West, Florida was held in Commission Chambers, Old City Hall, on Tuesday, April 3, 2012.

Mayor Craig Cates called the meeting to order at 6:02 p.m.

sites used are based on the severity of a storm. Each year he applies to FDEP for the site designation.
