Commercial district section, by removing language HRCC-1, HRCC-2 and to replace with the

language "Core Commercial district means the HRCC-1 and HRCC-2 zoning districts" and

seconded by Commissioner Yaniz for approval.

The Mayor acknowledged the motion and second and requested verbal approval. The

response was unanimous to pass the amendment.

It was moved by Commissioner Johnston to amend Section 26-191 Definitions:

Disturbing noise section by adding to the first sentence the language "unreasonably excessive

noise that is" and seconded by Commissioner Lopez for approval.

It was moved by Commissioner Lopez to amend Section 26-192 Unreasonably Excessive Noise prohibited, Section 2) striking the language In all areas of the City of Key West, other than those areas listed in subsection (b) (a) above: and seconded by Commissioner Rossi for approval.

The Mayor acknowledged the motion and second and requested verbal approval. The response was unanimous to pass the amendment.

It was moved by Commissioner Rossi to amend Section 26-192 Unreasonably Excessive Noise prohibited, Section 2.) by adding the language "In any Residential or Commercial District as defined in this Article, a decibel meter shall be used for a complaint of unreasonable noise made at or within 100 feet of the property line of the sound source. The decibel reading shall be made at the location of the complaint. The investigating officer shall issue a citation for unreasonably excessive noise, unless in his judgment a warning is sufficient to cease the violation. There shall be no more than a total of one warning per offending person or establishment in any six (6) month period and seconded by Commissioner Wardlow for approval.

The Mayor acknowledged the motion and second and requested the Clerk to call the roll.

It was moved by Commissioner Yaniz to amend Section 26-192 Unreasonably Excessive

Noise prohibited, Section 3.) by adding the language "A complaint of disturbing noise may be

made when the location of the complaint is beyond 100 feet of the property line of a Commercial

District property sound source. Additionally, a complaint of disturbing noise may be made when

the location of the complaint is a residential property and the location of the sound source is a

residential property at any distance from each other. A decibel meter measurement is not

required to determine disturbing noise. The investigating officer shall issue a citation if the

complainant suffers disturbing noise within the boundaries of his property. The investigating

officer may issue a warning if in his judgment a warning is sufficient to cease the violation.

There shall be no more than a total of one warning per offending person or establishment in any

six (6) month period and seconded by Commissioner Wardlow for approval.

The Mayor acknowledged the motion and second and requested the Clerk to call the roll.

It was moved by Commissioner Weekley to amend Section 26-192 Unreasonably Excessive Noise prohibited, by re-numbering subsection three (3) to number four (4) and seconded by Commissioner Johnston for approval.

The Mayor acknowledged the motion and second and requested verbal approval. The response was unanimous to pass the amendment.

It was moved by Commissioner Yaniz to amend Section 26-194 Citation procedure and penalties, subsection (e) to strike section 1-15 and replace with the language "Chapter 2, Article VI, Division 2 of the Code of Ordinances for the City of Key West" and seconded by Commissioner Lopez for approval.

The Mayor acknowledged the motion and second and requested verbal approval. The response was unanimous to pass the amendment.

It was moved by Commissioner Wardlow to amend Section 26-195 Liability; citizen suit by striking language in second sentence maker or creator and replace with language "individual controlling or responsible for maintaining the volume of unreasonably excessive" and seconded by Commissioner Weekley for approval.

The Mayor acknowledged the motion and second and requested the Clerk to call the roll.

It was moved by Commissioner Yaniz to amend Section 26-195 Liability; citizen suit subsection (d) by adding the title "Multiple Unsubstantiated Complaints" and by adding the language "An unsubstantiated complaint is one to which a noise control officer has responded and found either no evidence of any noise, or sound that is ten (10) decibels or more below the standard for the finding of a violation of unreasonably excessive noise. The noise control office

shall explain his or her finding to the complainant and detail the relevant standards for determining a violation as specified by the City Code. It shall be a violation of this Article subjecting an individual to the provisions of Chapter 2, Article VI, Division 2 of the Code of Ordinances for the City of Key West for any individual to make three (3) or more unsubstantiated complaints against the same property within a one (1) month period or five (5) total complaints in any twelve (12) month period" and seconded by Commissioner Rossi for approval
