A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RATIFYING AN EMERGENCY PROCUREMENT DATED FEBRUARY 2, 2022 APPROVED BY THE CITY MANAGER AS PROVIDED FOR UNDER SECTION 2-797(2) OF THE CODE OF ORDINANCES, AUTHORIZING A PROCUREMENT FROM EVOQUA WATER TECHNOLOGIES, LLC IN AN AMOUNT NOT TO EXCEED \$148,452.00 TO REBUILD/REPLACE THE CLARIFIER AT THE WASTEWATER TREATMENT PLANT; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the sewer plant is currently operating with only one of two clarifiers in operating condition, due to catastrophic failure. The equipment is critical, and the lead time for obtaining parts could result in extreme risk, if not acted on immediately; and

WHEREAS, City staff and contractors determined that Evoqua Water Technologies is the sole source distributor of the specific equipment used, and for trained and certified field techs for that equipment. The equipment is the best choice for the City's purposes; and

WHEREAS, the City Manager acted without delay, using emergency powers authorized under Section 2-797(2) of the City's Code of Ordinances, to authorize the necessary procurement to ensure prompt repair/rebuild of the two clarifiers at the wastewater treatment plant; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached emergency declaration dated February 2, 2022 by the City Manager, pursuant to section 2-797(2) of the Code of Ordinances, to rebuild/replace critically necessary clarifiers at the WWTP, to Evoqua Water Technologies, LLC in an amount not to exceed \$148,452.00 is hereby ratified.

Section 2: That this task order will be paid from budget account Sewer/WWTP/CIP 401-3504-535-6500. A budget transfer to that account is hereby authorized from Sewer/General Admin/Operating Reserves Account 401-3501-535-9803, and any necessary transfers are hereby authorized.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
