Description of Work: Demolition of existing wood staircase.

Building Facts: The building located at 222 Duval Street is listed as a

contributing resource. The two-story frame vernacular house was built c. 1889, and has had an exterior staircase since at least 1912. The staircase in question

is not historic, as evidenced by a 1986 survey.

Review: Sec. 102-217 (2): Demolition of non-historic or non-

contributing buildings, Sec. 102-218: Criteria for demolitions, and Sec. 102-125: Historic architectural review commission findings precedent to issuance in

the Land Development Regulations.

Staff Analysis

The Certificate of Appropriateness in review proposes the demolition of a non-historic staircase on the south side of a contributing structure. The application also includes repairing and painting the siding of the historic building as needed, but in general, this application will have little effect on the contributing resource.

It is staff's opinion that the proposed demolition will not cover historic elements. In addition, the stairs are in poor condition and need to be replaced. The more recent survey also shows that the stairs encroach on city property and should be removed. The stairs not meet any of the criteria listed in Sec. 102-125 (1) through (9), and therefore can be considered for demolition. If the demolition is approved this will constitute the only review for this request.

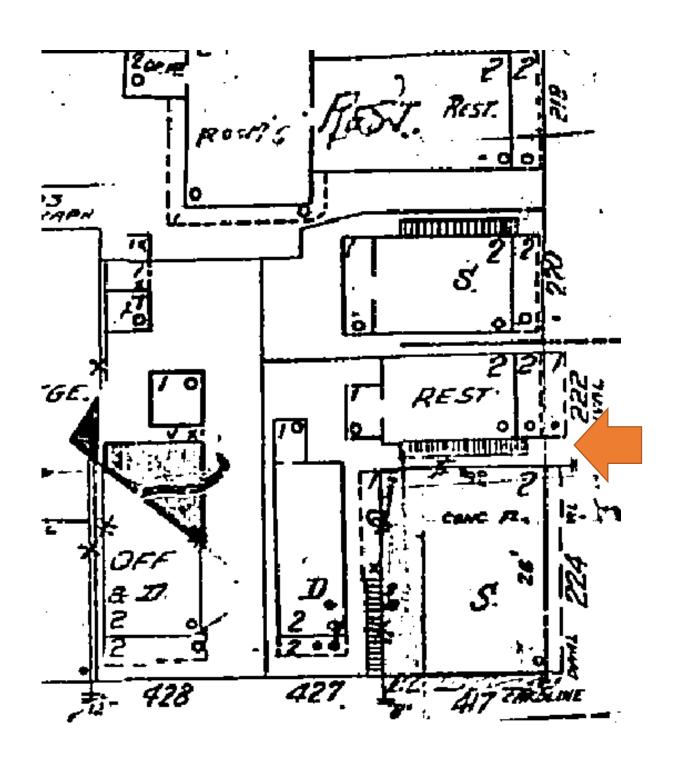
1912 Sanborn Map
