A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE PURCHASE OF RUBBER SURFACE MATERIAL FROM PERKEPAVE, LLC. IN AN AMOUNT NOT TO EXCEED \$64,484.00, FOR IMPROVEMENT AND REPAIRS TO CERTAIN AREAS WITHIN COFFEE BUTLER AMPHITHEATER PURSUANT TO 2-797(4)(b) OF THE CODE OF ORDINANCES, BEST INTERESTS OF THE CITY; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS AND ADJUSTMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, there are areas in the seating area of the Coffee Butler Amphitheater where rubber surface material should be installed in place of grass for both safety and convenience; and

WHEREAS, some members of City staff are trained and capable of installing certain ASTM-compliant rubber surface material, which is sold by only two companies, Flexi-Pave and perkEpave; and

WHEREAS, City staff obtained price quotes for rubber surface material from both vendors, with perkEpave providing the lowest bid, and City staff believes there would be no pricing advantage to issuing a formal ITB; and

WHEREAS, the City Manager believes that for the foregoing reasons stated herein, this purchasing exception qualifies as Exceptional Circumstances contemplated by Section 2-797(4)(b) of the code of Ordinances; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of rubber surface material from perkEpave, LLC. in an amount not to exceed \$64,484.00 is hereby approved for improvements/repairs at the Coffee Butler Amphitheater, pursuant to Section 2-797(4), best interests, of the code of ordinances.

Section 2: That adequate funding is budgeted for this project in Infrastructure Surtax/Truman Waterfront Capital Improvements Account 101-4303-543-63.

Section 3: That the City Manager or designee is authorized to execute any necessary documents, upon the advice and consent of the City Attorney.
