**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING PROPOSED FUNDING FOR THE GUIDANCE/CARE CENTER, INC. (GCC) FOR SECURITY UPGRADES TO THE CENTRAL RECEIVING FACILITY FOR MONROE COUNTY IN THE AMOUNT OF \$25,000.00; AUTHORIZING NECESSARY BUDGET ADJUSTMENTS; PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, the Guidance/Care Center, Inc. (GCC) is a non-profit organization which provides essential services for public benefit, including providing a centralized receiving facility for individuals who need emergency mental health or substance abuse disorder care, including those detained by local law enforcement under the Marchman Act or Baker Act; and

WHEREAS, in FY 19 the GCC provided services for 2,909 individuals, of which 1,400 were from Key West; and

WHEREAS, the GCC's centralized receiving facility for Monroe County is in need of security upgrades and additional improvements, for which it has requested partial funding from communities it serves; and

WHEREAS, the City Commission finds that GCC provides essential public services, which the City should help to sustain with funding in the amount of \$25,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That funding in FY 19-20 in the amount of \$25,000.00 for the Care Center for Mental Health's proposed Central Receiving Facility security improvements is hereby authorized, and the City Manager is hereby authorized to distribute those funds.

Section 2: That these funds shall be allocated from the City Manager's General Fund Contingency Account, and any necessary budget adjustments are here by authorized.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
