A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING NICHOLS SCANLON FOUNDATION INC. DBA MAX'S ANGELS TO CONDUCT THE "REELIN FOR THE CAUSE KIDS FISHING TOURNAMENT" ON THE EDWARD B. KNIGHT PIER ON SATURDAY, APRIL 25, 2026, FROM 3:00 P.M. TO 8:30 P.M. (SETUP AT 1:00 P.M.); PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Nichols Scanlon Foundation DBA Max's Angels has applied to the city for a Special Event Permit for their "Reelin for the Cause Kids Fishing Tournament" on the Edward B. Kinight Pier on Saturday, April 25, 2026, from 3:00 p.m. to 8:30 p.m. (setup at 1:00 p.m.).

NOW THEREFORE, BE IT RESOLVED, BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA.

SECTION 1. That In Resolution 19-174, the City Commission directed the City Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law."

SECTION 2. That the vendor/lessee/licensee acknowledges the City's concern about the negative environmental impact of using disposable polystyrene products, which are neither readily

recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and "to go" packages for food or products sold on any property leased from the City.

SECTION 3. That Nichols Scanlon Foundation DBA Max's Angels is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the time and place as herein described; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; and that the organization meets the terms and conditions set forth by the City Manager.

SECTION 4. That Nichols Scanlon Foundation DBA Max's Angels is hereby granted permission for the use of the Edward B. Knight Pier.

SECTION 5. That Nichols Scanlon Foundation DBA Max's Angels will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

SECTION 6. That pursuant to Section 18-86 of the Code of Ordinances, Nichols Scanlon Foundation DBA Max's Angels is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

SECTION 7. That Nichols Scanlon Foundation DBA Max's Angels must post the required notice regarding prohibition of purchase and

consumption of alcoholic beverages to persons under 21 years of age. Proof of compliance with Supplement F, paragraph 3 of the application is required at least ten (10) days in advance.

SECTION 8. That Nichols Scanlon Foundation DBA Max's Angels acknowledges that they are responsible for payment to the Key West Police Department, the Key West Fire Department and Community Services.

SECTION 9. That this resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
