**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE STAFF RANKING FOR GENERAL ARCHITECTURAL SERVICES IN RESPONSE TO RFQ NO. 22-010; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO CONTRACTS ON A TASK ORDER BASIS WITH THE SIX SELECTED ARCHITECTURAL FIRMS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, the City issued a request for Qualifications for firms capable of providing general architectural services for the City of Key West, on July 27<sup>th</sup>, 2022, and opened the qualification packages on September 7<sup>th</sup>, 2022; and

WHEREAS, as multiple City departments manage simultaneous projects of diverse sizes and specialties, the City prefers to contract with multiple firms to address the workload; and

WHEREAS, a ranking committee composed of city staff reviewed the eight (8) responsive responses to the RFQ for General Architectural Services at a public meeting on October 6<sup>th</sup>, and developed a list of the six highest ranked firms, and recommends that the City engage each of the six highest-ranked firms on a Task Order basis.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the top six responses in response to RFQ No. 22-010, for general architectural services are hereby ranked by a staff ranking committee, and approved by the City Commission as follows:

- (1) Bender and Associates Architects, PA
- (2) William P. Horn Architect, P.A.
- (3) CPH, LLC
- (4) K2M Design, Inc.
- (5) PFB Architects
- (6) West Architecture + Design, LLC

Section 2: That the City Manager is hereby authorized to negotiate and execute contracts on a task-order basis with each of the six top-ranked companies, upon advice and consent of the City Attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
