Shopping Carts	

This Business Impact Estimate is provided in accordance with section 166.041(4), Florida Statutes. In accordance with the provisions of controlling law, even notwithstanding the fact that an exemption noted above may apply, the City of Key West hereby publishes the following information:

Abandoned shopping carts create a nuisance on public and private properties throughout the city and with cleanliness being a priority in the City's Strategic Plan there needs to be regulation regarding the unlawful removal of shopping carts from businesses, besides a person being subject to arrest by the KWPD.

Abandoned shopping carts tend to be left on City streets and sidewalks causing obstructions and are also utilized to contain refuse. This proposed addition to the City's Code of Ordinances would allow Code Compliance to enforce this regulation against the Corporation by issuing the violation to the store manager.

- 2. An estimate of the direct economic impact of the proposed ordinance on private, forprofit businesses in the City of Key West, if any:
- (a) An estimate of direct compliance costs that businesses may reasonably incur; 6"x4" Placard for individual shopping carts, \$11.25 each. 12"x18" Individual sign for exits, \$42.50 each.
- (b) Any new charge or fee imposed by the proposed ordinance or for which businesses will be financially responsible;

Twenty dollars for the cost of permit.

(c) An estimate of the City of Key West's regulatory costs, including estimated revenues from any new charges or fees to cover such costs.

Twenty dollars per permit per 12 businesses = \$240.00 annually.
