A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING AMENDMENT NO. 1 TO THE PUBLIC TRANSPORTATION GRANT AGREEMENT (PTGA) #G3B99 BETWEEN THE CITY OF KEY WEST AND THE FLORIDA DEPARTMENT OF TRANSPORTATION UNDER THE TRANSIT CORRIDOR DEVELOPMENT PROGRAM TO INCLUDE THE TRANSMISSION IN THE PROJECT SCOPE FOR THE REPAIR OF BUS 904, WITH NO CHANGE TO THE ORIGINAL GRANT AMOUNT OF \$10,000.00; AUTHORIZING THE CITY MANAGER TO EXECUTE THE NECESSARY DOCUMENTS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Key West entered into a Public Transportation Grant Agreement (PTGA) #G3B99 with the Florida Department of Transportation (FDOT) under the Transit Corridor Development Program for the replacement of the engine on Bus 904; and

WHEREAS, during the course of the engine replacement, the transmission was inspected and found to be faulty due to the presence of metal shavings, requiring its replacement; and

WHEREAS, Amendment No. 1 to PTGA #G3B99 adds the transmission to the project scope as described in Exhibit A, Item A, Project Description, with the grant amount remaining unchanged at \$10,000.00; and

WHEREAS, the grant remains 100% reimbursable to the City in an amount not to exceed \$10,000;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: The City Commission hereby approves Amendment No. 1 to the Public Transportation Grant Agreement #G3B99 with the Florida Department of Transportation under the Transit Corridor Development Program to include the transmission in the project scope.

Section 2: The City Manager is hereby authorized to execute Amendment No. 1 and all necessary documents on behalf of the City of Key West, upon advice and consent of the City Attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
