SUBJECT: Quitclaim deed agreements for North Roosevelt Blvd. sidewalk construction and granting relief from the City's land development regulations where such conveyances would impair future development

## **ACTION STATEMENT:**

This resolution will authorize the City Manager to enter into and execute all documents necessary to obtain quitclaim deed agreements for construction of a sidewalk with property owners along the south side of North Roosevelt Blvd and authorize conveyance of these quitclaim deed agreements to Florida Department of Transportation (FDOT). Additionally the resolution will grant relief from the City's land development regulations to the property owners where such conveyances could impair future development on their property.

#### **BACKGROUND:**

FDOT is developing the design to rebuild State Road (S.R.) 5/North Roosevelt Blvd from Eisenhower Drive/Jose Marti Drive to US 1/Overseas Highway (does not include the triangle). The work also includes the repaying of the road from south of the intersection with US 1 Overseas Highway to the Riviera Canal Bridge and from Bertha Street to the east end of Smather's Beach along the South Roosevelt Blvd. segment. The project includes the following:

- New sidewalk on the south side
- Rebuilding of the seawall along the north side
- Rebuilding of the road to create two northbound and two southbound lanes with a center turn lane
- · Rebuilding the sidewalk, curb and gutter along the south side
- Installing a new drainage system

- Improving drainage outlets at Cow Key Bridge and Riviera Canal
- · Replacing traffic signals with mast arms traffic signals
- Installing new signs and pavement markings
- Installing a new lighting system
- Planting new Coconut Palm trees and relocating existing ones

#### **PURPOSE & JUSTIFICATION:**

In order to construct a sidewalk on the south side of the Blvd., the City on behalf of FDOT will attempt to secure quitclaim deed agreements from 26 parcels along that side of the road (property owners/addresses of parcels attached). Several of the parcels contain more then one property but one owner. Additionally there are several of the parcels that may be owned by one owner.

The City's original plans were to secure easement agreements with the property owners and grant relief from the City's land development regulations (see attached Resolution 04-367, 09-288, and 10-225), but neither the FDOT nor City could indemnify property owners from liability issues associated with construction of the sidewalk on the privately owned parcels. FDOT had originally agreed to provide the indemnification. By quitclaim deeding the properties, FDOT will own the property and assume the liability associated with the sidewalk. Additionally the City is granting relief from the City's land development regulations to the property owners where such conveyances could impair future development on their property.

These actions will allow the construction of the \$24,100,000 North Roosevelt Blvd project to proceed as designed by FDOT. Currently plans are 90% complete and construction is slated to begin April 2012 and last 800 days. If the City does not acquire and convey the quitclaim deed agreements there is a chance the south side sidewalk will not be constructed.

#### **OPTIONS:**

- 1. Approval of the Action Statement in its entirety.
- 2. Approval of a modified Action Statement as determined by the City Commission
- 3. Disapprove the Action Statement

#### FINANCIAL IMPACT:

There is no financial impact associated with this action.

#### **RECOMMENDATION:**

City staff recommends option # 1, that the City Commission authorize the City Manager to enter into and execute all documents necessary to obtain quitclaim deed agreements for construction of a sidewalk with property owners along the south side of North Roosevelt Blvd and authorize conveyance of these quitclaim deed agreements to Florida Department of Transportation (FDOT). Additionally City Staff recommends granting relief from the City's land development regulations to the property owners where such conveyances could impair future development on their property.

#### RESOLUTION NO. 09-288

A RESOLUTION OF THE CITY COMMISSION OF THE FLORIDA, KEY WEST, ENCOURAGING CITY OF PROPERTY OWNERS ALONG NORTH ROOSEVELT BOULEVARD TO CONVEY SMALL PORTIONS OF PROPERTY TO FDOT FOR THE CONSTRUCTION OF ADA APPROVED SIDEWALK RAMPS; GRANTING RELIEF FROM THE CITY'S LAND DEVELOPMENT REGULATIONS WHERE SUCH CONVEYANCES IMPAIR FUTURE DEVELOPMENT: PROVIDING FOR AN EFFECTIVE DATE

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City of Key West, Florida, has requested property owners along North Roosevelt Boulevard to grant easements to the City for the construction and maintenance of ADA approved sidewalks on the south side of North Roosevelt Boulevard from Jose Marti/Truman Drive to South Roosevelt.

Section 2: That, in connection with the project referred to herein above, the Florida Department of Transportation (FDOT) wishes to acquire small parcels of property from those property owners in order to construct ADA approved sidewalk ramps.

Section 3: That in order to encourage property owners to convey those small parcels to FDOT referred to herein above, in the event any such conveyance results in the failure of a lot, parcel, structure or use to comply with the provisions of the Code of Ordinances of the City of Key West (hereinafter the "Code"), including, but not limited to, set backs, parking, open space, pervious versus impervious area, floor area ratios, landscaping and

landscape buffers, and signage set backs, same shall be considered legally nonconforming pursuant to Sections 122-26 through 122-32 of the Code. Any legally nonconforming status established pursuant to this Resolution shall run with the land and inure to the benefit of future owners of the properties so affected. Specifically, the conveyance shall not result in any detriment to or limitation of the owner's existing development and/or use rights.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, DIRECTING STAFF TO ATTEMPT TO OBTAIN PREPARE AND EASEMENTS FOR THE BENEFIT OF, AND SUBSEQUENT CONVEYANCE TO, THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) ON THE SOUTH SIDE OF NORTH ROOSEVELT BOULEVARD, FOR THE PURPOSE OF IMPLEMENTING THE FDOT PLAN TO IMPROVE THE ROAD AUTHORIZING AND CONSTRUCT SIDEWALKS; EXECUTION OF A QUIT CLAIM DEED FOR PROPERTY ALONG THE NORTH SIDE OF NORTH ROOSEVELT BOULEVARD IN FAVOR OF THE FDOT; AUTHORIZING THE EXECUTION OF A WARRANTY DEED FOR 200 SOUARE FEET OF PROPERTY KNOWN AS PARCEL 124 ALONG NORTH ROOSEVELT BOULEVARD IN FAVOR OF THE FDOT IN ACCORDANCE WITH CITY CHARTER PROVISION 7.03(A); PROVIDING FOR AN EFFECTIVE DATE

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That staff is hereby directed to proceed with obtaining and subsequently conveying to the FDOT roadway easements necessary for the implementation of the FDOT plan to improve the right of way and construct sidewalks along the south side of North Roosevelt Boulevard.

Section 2: That the City Manager is authorized to execute a

quit claim deed for property along the north side of North Roosevelt Boulevard, as well as a warranty deed for parcel 124, in accordance with Key West City Charter 7.03(a).

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
