A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED AMENDMENT 1, CHANGING THE PROJECT SCOPE FROM ONE REPLACEMENT VAN TO UP TO TWO VEHICLES AND **AMENDMENT** EXPIRATION EXTENDING THE DATE 2026, OF OCTOBER 1, THE "PUBLIC TRANSPORTATION GRANT AGREEMENT" #G2X82, BETWEEN THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) AND THE CITY OF KEY WEST FOR SFY2024 FTA SECTION 5339 RURAL BUS FACILITY AND BUS CAPITAL AUTHORIZING THECITY MANAGER EXECUTE NECESSARY DOCUMENTS, BUDGET TRANSFERS, ADJUSTMENTS OR AMENDMENTS, UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in Resolution 24-129, the City Commission approved to PTGA #G2X82 to purchase service vehicle; and

WHEREAS, funding through the FDOT Section 5339 Rural Bus and Bus Facility Capital funds, provides Capital assistance for the purchase of support equipment for buses and transit facilities; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached and incorporated herein, Amendment 1, changing the project scope from one (1) replacement van to up to two (2) support vehicles, and Amendment 2, extending the expiration date to October 1, 2026, of the "Public Transportation Grant Agreement" PTGA #G2X82,

between FDOT and the City of Key West, for Section 5339 Rural Bus and Bus Facility Capital funds, are hereby approved.

Section 2: That the City Manager is authorized to effectuate any necessary budget transfers, adjustments or amendments in accordance with such grant, and to execute any necessary documents, upon consent of the City Attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
