An application was received requesting the removal of **(1) Royal Poinciana tree**. A site inspection was done on January 24, 2018 and documented the following:

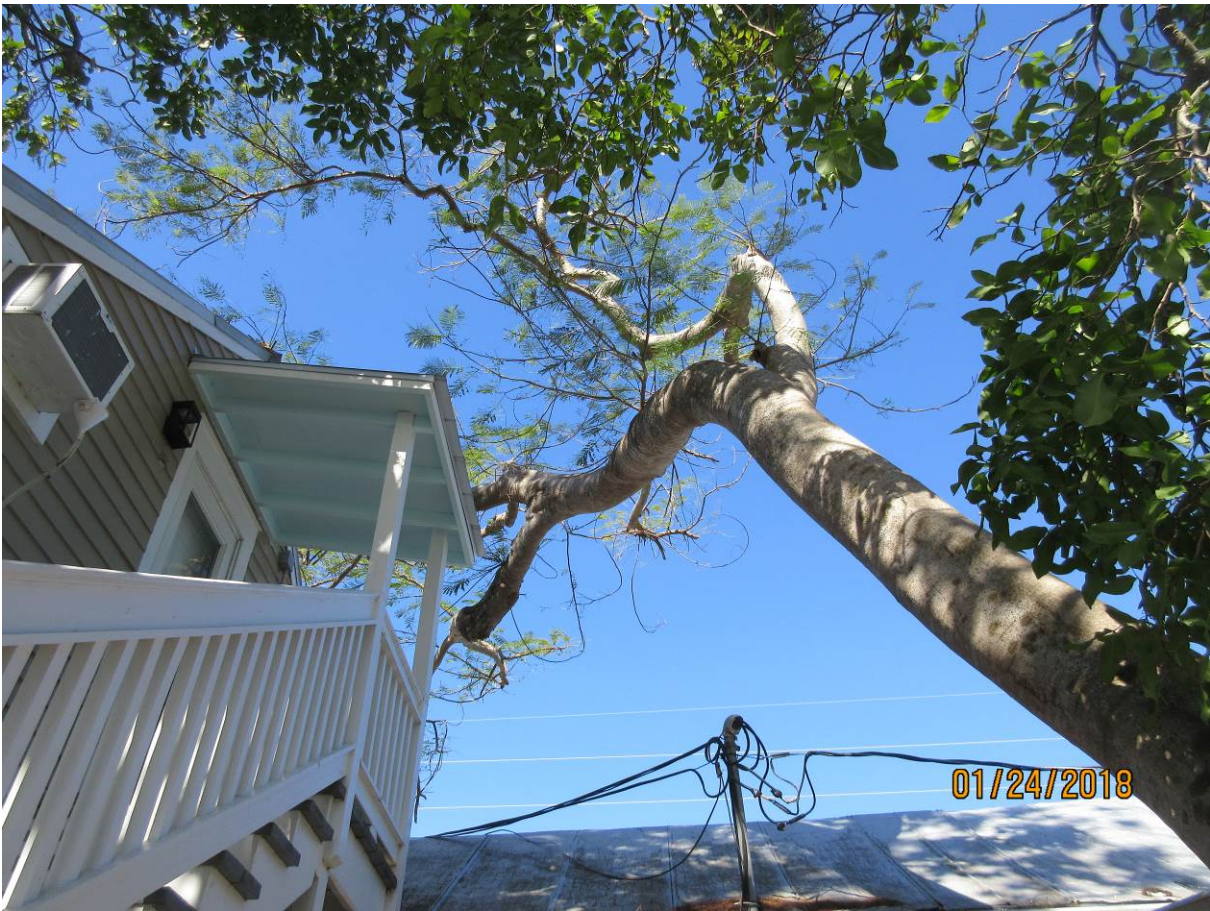
Tree Species: Royal Poinciana (Delonix regia)

Diameter: 19.1"

Location: 60% (growth close to another large canopy tree, canopy above house electrical feeder line)

Species: 100% (on protected tree list)

Condition: 60% (fair, heavy growth lean due to adjacent large canopy tree, buttress root system)

Total Average Value = 73%

Value x Diameter = 13.9 replacement caliper inches

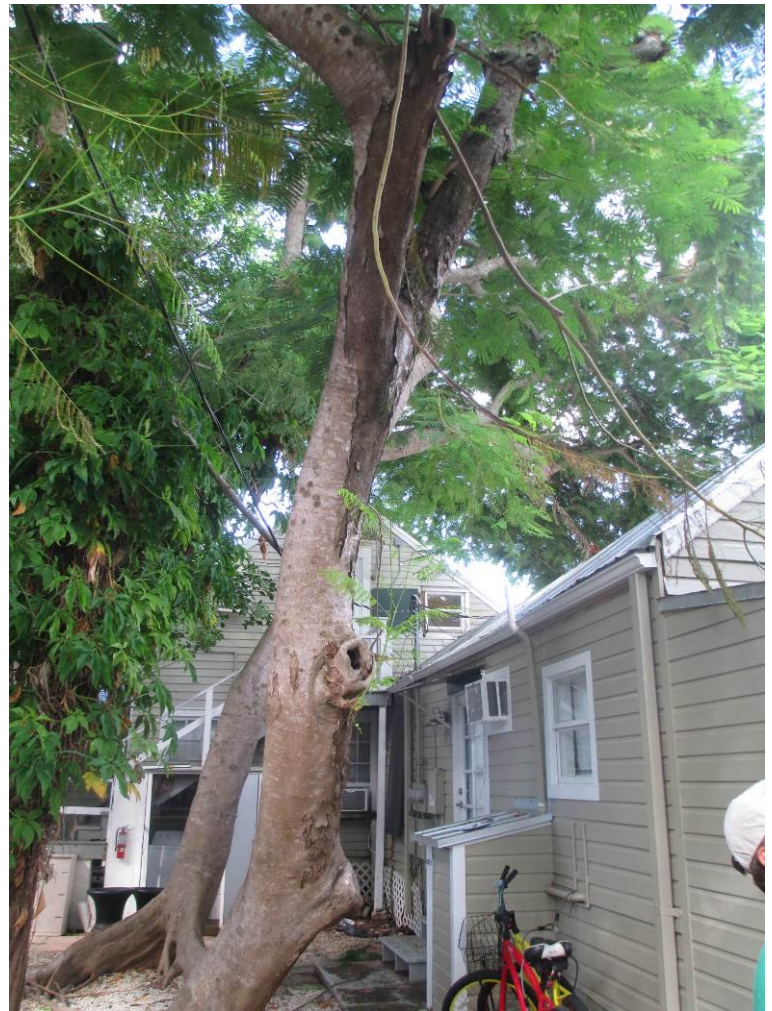
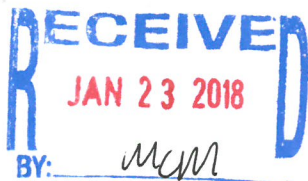

There does not seem to be a lot of change from 2015 to 2018 with the tree.

In 2015, the Royal Poinciana tree in the fore front of the photos was approved for removal and in 2017 the Spanish lime tree canopy was reduced by the removal of a small tree growing from the roots.

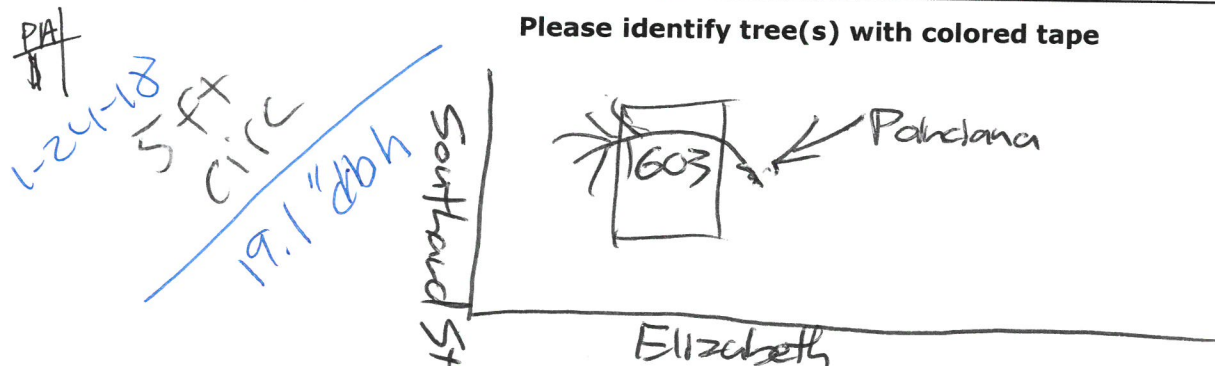

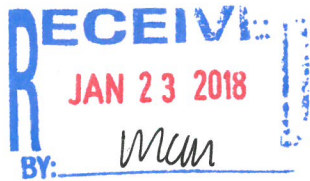
