A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING ULTRA SPORTS LLC TO CONDUCT THE 18TH ANNUAL KEYS100 ULTRAMARATHON ON HIGGS BEACH FROM 3:00 P.M. ON SATURDAY, MAY 16, 2026 TO 3:00 P.M. ON SUNDAY, MAY 17, 2026, (SET-UP BEGINNING AT 12:00 P.M. SATURDAY, MAY 16, 2026); PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN AN ENCLOSED AREA; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Ultra Sports LLC wishes to conduct the 18th Annual KEYS100 Ultramarathon on Higgs Beach beginning at 3:00 p.m. on Saturday, May 16, 2026, through 3:00 p.m. on Sunday, May 17, 2026, (setup at 12:00 p.m. on Saturday, May 16, 2026).

NOW THEREFORE, BE IT RESOLVED, by the City Commission of the City of Key West, Florida.

SECTION 1. That in Resolution 19-174, the City Commission directed the City Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the provision of good or services, unless such use is otherwise preempted by law."

SECTION 2. "That the vendor/lessee/licensee/contractor acknowledges the City's concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor, therefore, commits to refrain

from the use or distribution of single-use polystyrene/plastic items, including but not limited to single-use polystyrene/plastic straws, bags, plastic utensils and "to go" packages for food or products sold on any property leased from the City."

SECTION 3. That Ultra Sports LLC is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the time and place as herein described; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; and that the organization meets the terms and conditions set forth by the City Manager.

SECTION 4. That Ultra Sports LLC will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash container will be used and that they will be placed side by side.

SECTION 5. That pursuant to Section 18-86 of the Key West Code of Ordinances, Ultra Sports LLC is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

SECTION 6. Ultra Sports LLC must post the required notice regarding prohibition of purchase and sale of alcoholic beverages to persons under 21 years of age. Proof of compliance with Supplement F, paragraph 3 of the application is required at least

ten (10) days in advance.

SECTION 7. That Ultra Sports LLC acknowledges that they are responsible for payment to the Key West Police Department, the Key West Fire Department and Community Services.

SECTION 8. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
