SECTION 2. That Finnegan's Wake Irish Pub & Eatery is hereby granted permission for the closure of James Street between Grinnell and Margaret Streets on the date and during the hours stated above.

SECTION 3. That Finnegan's Wake Irish Pub & Eatery is granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place

and time herein described.
