A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE INCREASE TO PURCHASE ORDER #P100963 IN THE AMOUNT OF \$58,359.00, NOT TO EXCEED \$1,238,879.00 FOR THE PROCUREMENT OF THE GILLIG LOW FLOOR ELECTRIC BUS; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS, UPON CONSENT OF THE CITY ATTORNEY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Purchase Order No. P100963 was previously approved for procurement purposes; and

WHEREAS, it has been determined that an increase in funding is necessary to fulfill the requirements associated with said purchase order;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: The City Commission hereby authorizes an increase to Purchase Order No. P100963 in the amount of Fifty-Eight Thousand Three Hundred Fifty-Nine Dollars (\$58,359.00), resulting in a revised total purchase amount not to exceed One Million Two Hundred Thirty-Eight Thousand Eight Hundred Seventy-Nine Dollars (\$1,238,879.00), for the procurement of a Gillig Low Floor Electric Bus.

Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication

by the signature of the Presiding Officer and the Clerk of the Commission.
