**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE KEY WEST GATOR CLUB AS AN AFFILIATE OF THE UNIVERSITY OF FLORIDA ALUMNI ASSOCIATION, INC. TO CONDUCT A FULL AND ½ MARATHON ON FRIDAY OCTOBER 7, 2016 FROM 12:00 PM TO 9:00 PM & SATURDAY, OCTOBER 8, 2016 FROM 4:00 AM TO 2:00 PM; AUTHORIZING THE CLOSURE OF FRONT STREET FROM DUVAL STREET AND SIMONTON STREET INCLUDING SIMONTON STREET BEACH AREA; AUTHORIZING CERTAIN STREET CLOSURES THEREOF DURING THE EVENT; GRANTING AN EXEMPTION FROM THE NOISE CONTROL ORDINANCES PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 4:00 A.M. TO 12:00 NOON; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, permission is hereby granted the Key West Gator Club to conduct a Marathon and ½ Marathon on Saturday October 7, 2016 and Sunday, October 8, 2016;

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West, Florida;

**SECTION 1.** That permission is hereby granted to the Key West Gator Club to conduct a Marathon and ½ Marathon on the date and during the hours stated above; **PROVIDED** that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager.

**SECTION 2.** That the Key West Gator Club is hereby granted permission for the closure of certain streets throughout the city for the Marathons on the date and during the hours stated above.

**SECTION 3.** That the Key West Gator Club is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and

time herein described.

**SECTION 4.** That the Event organizers will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

**SECTION 5.** This Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
