A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE A SATISFACTION OF LIEN IN THE CASE OF JOHN MACLAUGHLIN, PROPERTY OWNER(S) OF 1922 PATTERSON AVENUE; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Key West holds a lien in the amount of \$236,250.00 plus accrued interest and additional daily fines until certain violations are brought into compliance against a property located at 1922 Patterson Avenue in Key West, FL, owned by John Maclaughlin by virtue of a code enforcement order originating in code compliance case number 10-00673 and duly recorded with the Monroe County Clerk of Court; and

WHEREAS, Florida Statute 162.09(3) mandates that a certified copy of an order imposing a fine, or a fine plus repair costs, may be recorded in the public records and thereafter shall constitute a lien against the land on which the violation exists and upon any other real or personal property owned by the violator; and

WHEREAS, the property owners brought the code violations at 1922 Patterson Avenue into compliance on April 6, 2017, and an affidavit of compliance has been filed and attached herein; and

WHEREAS, on October 30, 2018, a request for mitigation of lien was received by the Code Compliance Department, and placed on the City Commission agenda of November 7, 2018;

WHEREAS, the City Commission considered the request to release the lien imposed on the property located at 1922 Patterson Avenue.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Manager, upon the advice and consent of the City Attorney, is authorized to execute a Satisfaction of Lien in the case of John Maclaughlin, the owner of the property known as 1922 Patterson Avenue, to allow the City's release of lien without payment of any fee.

Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
