An application was received requesting the removal of **(1) Gumbo Limbo Dogwood tree**. A site inspection was done on August 25, 2017 and documented the following:

Tree Species: Gumbo Limbo (*Bursera simaruba*)

Diameter: 16.2"

Location: 60% (close to pool)

Species: 100% (on protected tree list)

Condition: 60% (fair-old injury in canopy, possible girdled roots)

Total Average Value = 73%

Value x Diameter = 11.8 replacement caliper inches

Cracks in the pool were not obvious or observed at the time of inspection. The property owner was asked to submit additional information regarding the damage by the tree roots to the pool and any pool leaks.

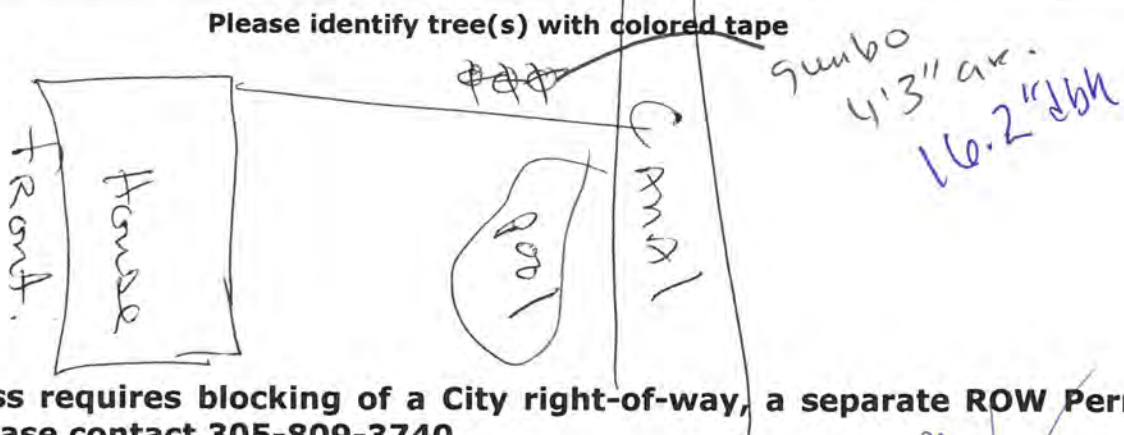
