**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE EVENT NETWORK-PIRATES IN PARADISE, FLORIDA SPECIAL EVENT'S ( HELPLINE FAIR), KEY WEST HELPLINE, INC. AND ADVANCED SOFT TISSUE ASSESSMENT & REHABILITATION (ASTAAR) INC, THE USE OF THE TRUMAN WATERFRONT AS DEPICTED ON THE MAP ATTACHED FOR THE PIRATES FESTIVITIES STARTING ON WEDNESDAY, NOVEMBER 23, 2011 (SET UP NOVEMBER 21, 2011) THROUGH SUNDAY, DECEMBER 4, 2011; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES THROUGHOUT THE EVENT; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE BARRICADED AREA ; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS,** The Event Network dba Pirates in Paradise Festival, Florida Special Events (Helpline Fair), ASTAAR Inc., Key West Helpline Inc. wishes to use the Truman Waterfront site between the hours of 10:00 a.m. to 10:00 p.m. daily during the event and during the Concert on Friday, December 2, 2011 for the Pirates in Paradise Festivities ; and

**WHEREAS,** this event shall take place on the grounds of the Truman Waterfront as depicted by the map attached; and

**NOW THEREFORE, BE IT RESOLVED,** by the City Commission of the City of Key West, Florida;

**SECTION 1.** That the Event Network – dba Pirates in Paradise, Florida Special Events (Helpline Fair), Key West Helpline Inc. and ASTAAR, Inc. is hereby granted permission for the use of the Truman Waterfront on the date and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantees

indemnifying the City is executed; and provided the organizations meet the terms and conditions set forth by the City Manager; and that 25% of gross revenue or \$1,000, whichever is greater, shall be donated to ASTAAR Inc. & Key West Helpline Inc.

**SECTION 2.** That pursuant to Section 18-86 of the Key West Code of Ordinances, permission is granted to allow the sale and consumption of alcoholic beverages within the enclosed area.

**SECTION 3.** That the Event Network dba Pirates in Paradise, Florida Special Events (Helpline Fair), ASTAAR Inc. and Key West Helpline Inc. are hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

**SECTION 4.** That any use of the Truman Waterfront properties should be Coordinated and approved through the Local Redevelopment Agency Office.

**SECTION 5.** That Premier Racing will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

**SECTION 6.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
