MINUTES

CITY COMMISSION MEETING

OLD CITY HALL, 510 GREENE STREET

WEDNESDAY, SEPTEMBER 5, 2012

A regular meeting of the City Commission of the City of Key West, Florida was held in Commission Chambers, Old City Hall, on Wednesday, September 5, 2012.

Mayor Craig Cates called the meeting to order at 6:00 p.m.

Answering roll call were Commissioners Teri Johnston, Clayton Lopez, Billy Wardlow, Jimmy Weekley, Tony Yaniz and Mayor Craig Cates.

Commissioner Mark Rossi was absent.

Also present were Assistant City Manager David Fernandez, Assistant City Manager Mark Finigan, City Attorney Shawn Smith, Assistant City Attorney Ron Ramsingh, City Planner Don Craig, Police Chief Donie Lee, Code Compliance Manager Jim Young, Port and Transit Director Jim Fitton, Transit Manager Myra Wittenberg, Senior Project Manager Doug Bradshaw, Utilities Manager Jay Gewin, Deputy City Clerk Angela Budde and Senior Deputy City Clerk Sue Harrison.

Reverend Dr. Randolph Becker, Unitarian Universalist Fellowship, gave the invocation.

The pledge of allegiance to the flag of the United States of America was given by all present.

CHANGES TO THE AGENDA:

Assistant City Manager Fernandez requested Resolution Item 5 be postponed to October 16, 2012. Without opposition the agenda was accepted as changed.

PRESENTATIONS:

Key West Historic Resources Survey 2011 - Stacey Griffin, Panamerican Consultants, Inc.

City Planner Don Craig introduced Ms. Griffin for the presentation.

City Attorney's Report

The City Attorney had no report. Commissioner Yaniz asked the City Attorney to clarify what constitutes a trailer versus a boat trailer in relation to the recent passage of the Ordinance related to parking on the City streets or right-of-ways. Mr. Smith spoke on the LDR rules set in 1997 and he suggested the Commission would be well served with a comprehensive review of the regulations with respect to parking in Chapter 70 and Chapter 108.

Commissioner Wardlow commented on covered vehicles and boats and trailers parked behind the police station on Duck Avenue.

Commissioner Johnston said the language is clear regarding the use of public right-of-way for storage. Mr. Smith defined storage as 72 hours but there are other regulations that prohibit vehicles for any length of time in another section of the Code.

Police Chief Donie Lee and Code Compliance Manager Jim Young responded to questions from the Commission regarding enforcement of the parking laws.

The City Attorney stated he would work with the Police Department and Code Compliance to bring something back before the Commission that is reasonable and clear.

City Manager's Report

Assistant City Manager Fernandez advised the Commission they had received the Glynn Archer Report Condition Analysis. Mr. Fernandez requested that staff be able to brief each Commissioner individually on the report and to set a special meeting for the engineers to present the report and answer questions. He stated October 24 is the expiration date for the due diligence period for the school board. The date for the special meeting was to be determined.

Mr. Fernandez asked Utilities Manager Jay Gewin to give a brief presentation on the Sewer Deduct Meter program and to discuss storm debris and/or vegetation.
