IN AN AMOUNT NOT TO \$144,451.00 FOR **EXCEED PROFESSIONAL** DESIGN SERVICES FOR THE SOUTH STREET ROADWAY IMPROVEMENTS PROJECT; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS OR ADJUSTMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 17-207, the City Commission approved a contract with CH2M Hill, Inc. for General Engineering Services, in Resolution 20-142 the contract was extended, and in Resolution 22-171 the contract was extended through December 31, 2022; and

WHEREAS, the South Street Improvements project will include ADA compliant sidewalks, pavement resurfacing, signing, striping, incorporation of a dedicated bicycle lane and improved drainage of South Street between Whitehead Street and Reynolds Street, and Reynolds Street from South Street to United Street; and

WHEREAS, City staff recommends authorization of this
Task Order which will enhance the health, welfare and safety
of residents and visitors of the City of Key West; and

Section 1: That the attached Task Order 9-22 ENG from CH2M Hill Engineering, Inc. for Design of the South Street Improvement Project is hereby approved in an amount not to exceed \$144,451.00.

Section 2: That funds for this project are budgeted in the Internal Improvements/Gas Tax Fund account #102-4102-541-6300, Project Code II41022202, and any necessary budget transfers or adjustments are hereby approved.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
