Description of Work

Demolition of non-historic rear addition and front porch. Partial demolition of rear wall and sheds

Site Facts

The building under review is a non-contributing but historic resource to the historic district. Built in 1948, the one-story frame vernacular house has been altered through the years, including the current front porch and a rear two-story addition with exterior stairs. Those alterations are not historic. The house has its original glass jalousie windows. The property and surrounding houses have ample front yards.

Ordinance Cited on Review:

• Section 102-217 (2), demolition for non-contributing or non-historic structures of the Land Development Regulations.

Staff Analysis:

The Certificate of Appropriateness proposes the demolition of non-historic elements, including rear wall of the house, two-story rear addition with stairs, front porch, and shed. It is staff's opinion that the proposed demolitions will be done for non-historic and non-contributing structures.



Areas proposed to be demolished.

Since the structures under review are non-historic, the evaluation shall be based on section 102-217 (b) of the Land Development Regulations, which requires the following criteria for demolitions:

The historic architectural review commission shall not issue permits that would result in:

(1) Removing buildings or structures that are important in defining the overall historic character of a district or neighborhood so that the character is diminished;

> It is staff's opinion that the structures under review are not important character defining features to the historic site. Their demolition, specifically the front porch and two-story rear addition will improve the appearance of the building.

(2) Removing historic buildings or structures and thus destroying the historic relationship between buildings or structures and open space;

The proposed structures to be demolished are not historic.

(3) Removing an historic building or structure in a complex; or removing a building facade; or removing a significant later addition that is important in defining the historic character of a site or the surrounding district or neighborhood.

The non-historic structures under review cannot be considered important elements that can define the historic character of the site and neighborhood. The existing front porch overshadows the historic building and drives attention due to its unusual form.

(4) Removing buildings or structures that would otherwise qualify as contributing, as set forth in <u>section 102-62(3)</u>.

It is staff's opinion that the structures under review will not qualify to be contributing to the district in a near future.

In conclusion, it is staff's opinion that the request for demolition of the rear wall of the house, front porch, two-story rear addition with stairs, and shed can be considered by the Commission as they meet the criteria for demolition stated under the Land Development Regulations. If approved, this will be the only required reading for demolition.

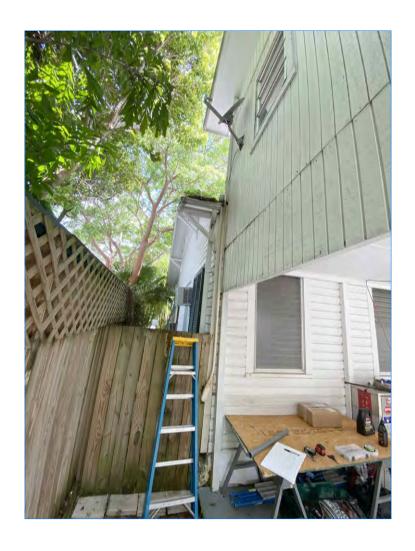

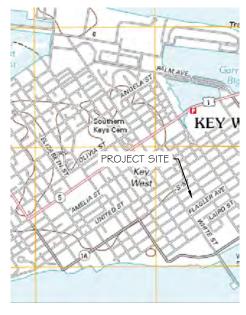

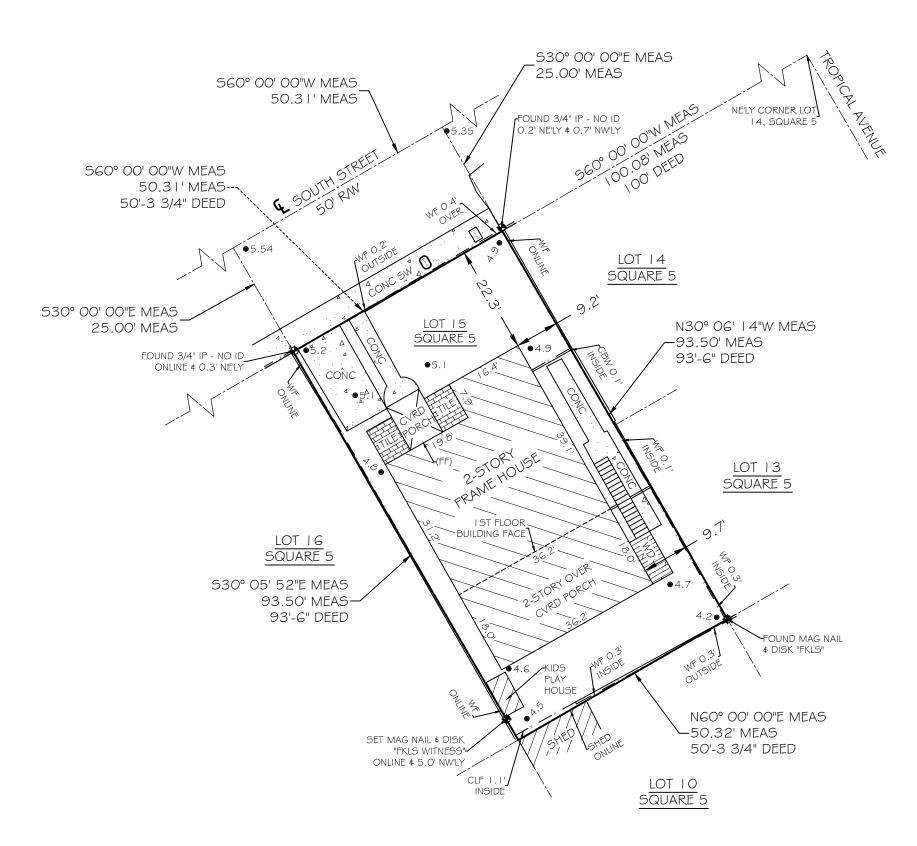


MAP OF BOUNDARY SURVEY

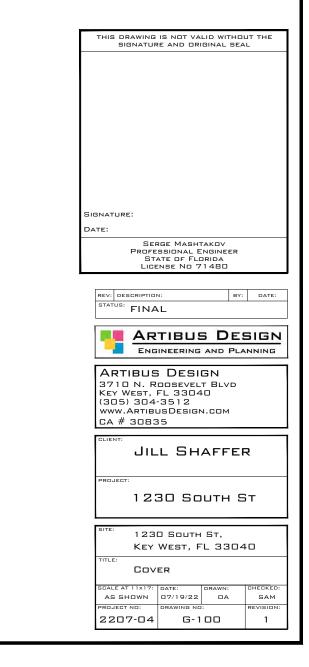

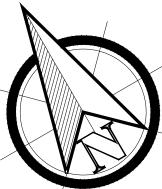

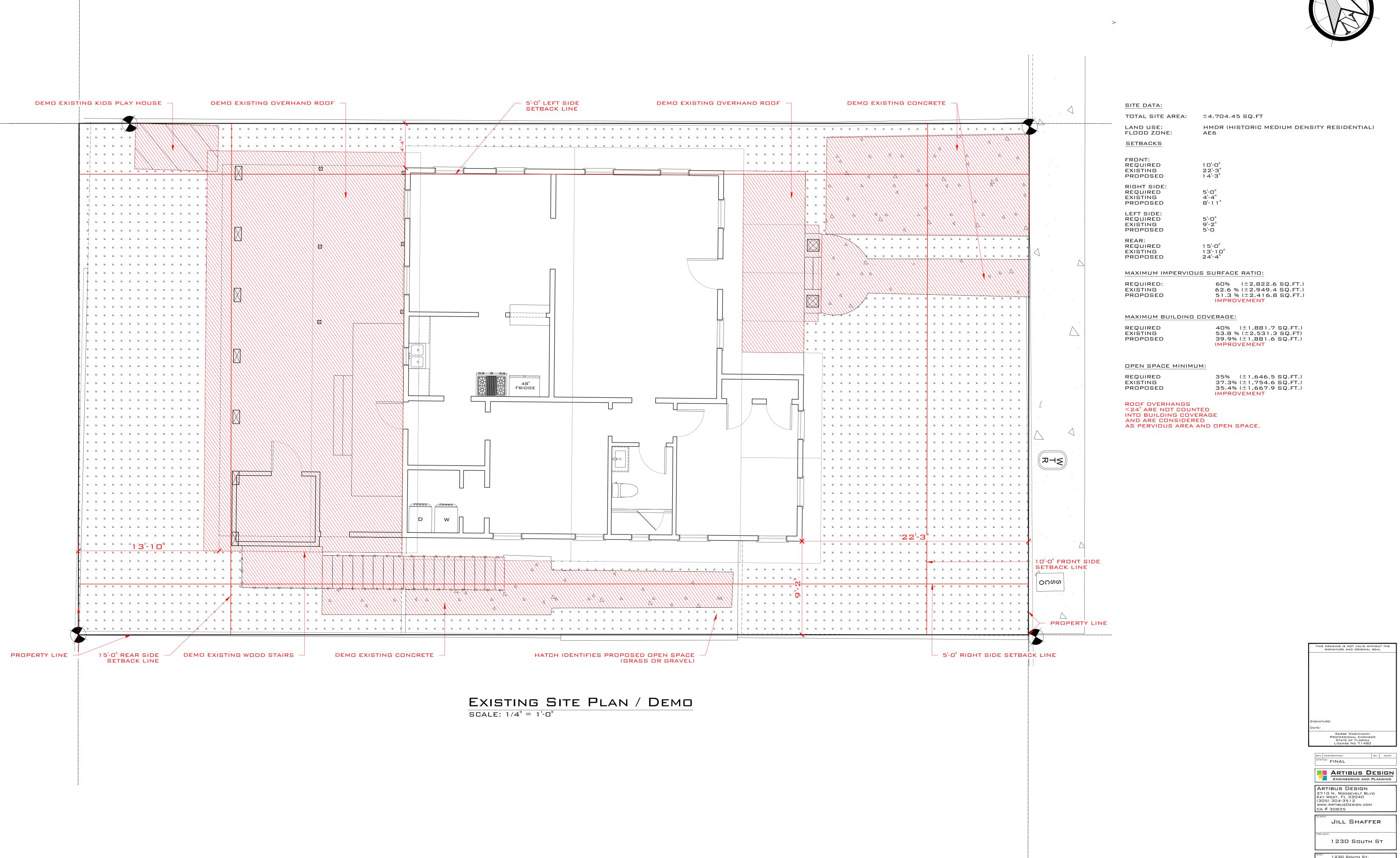


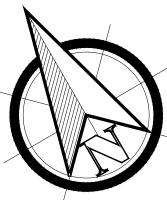


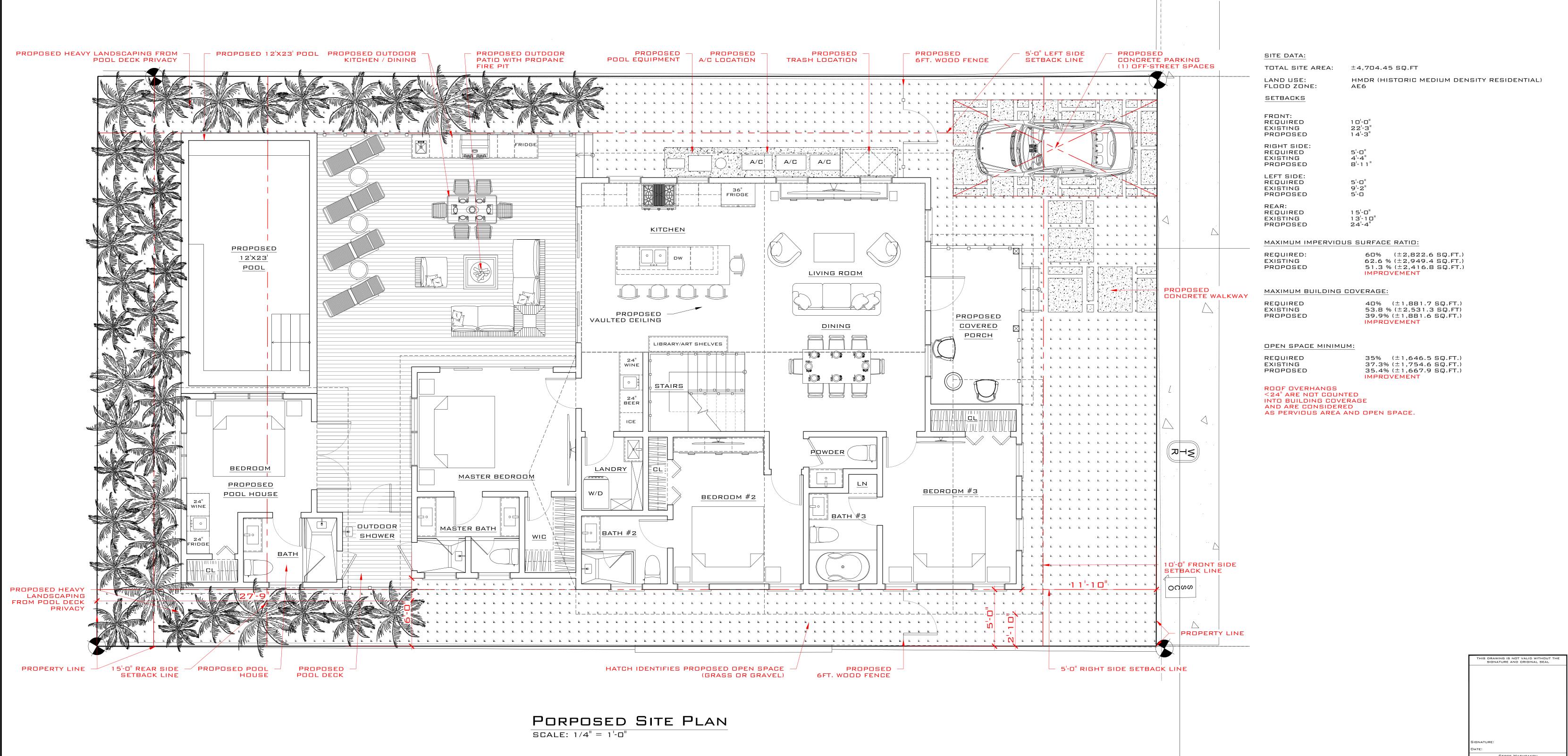
KEY WEST, FL 33040 EXISTING SITE PLAN

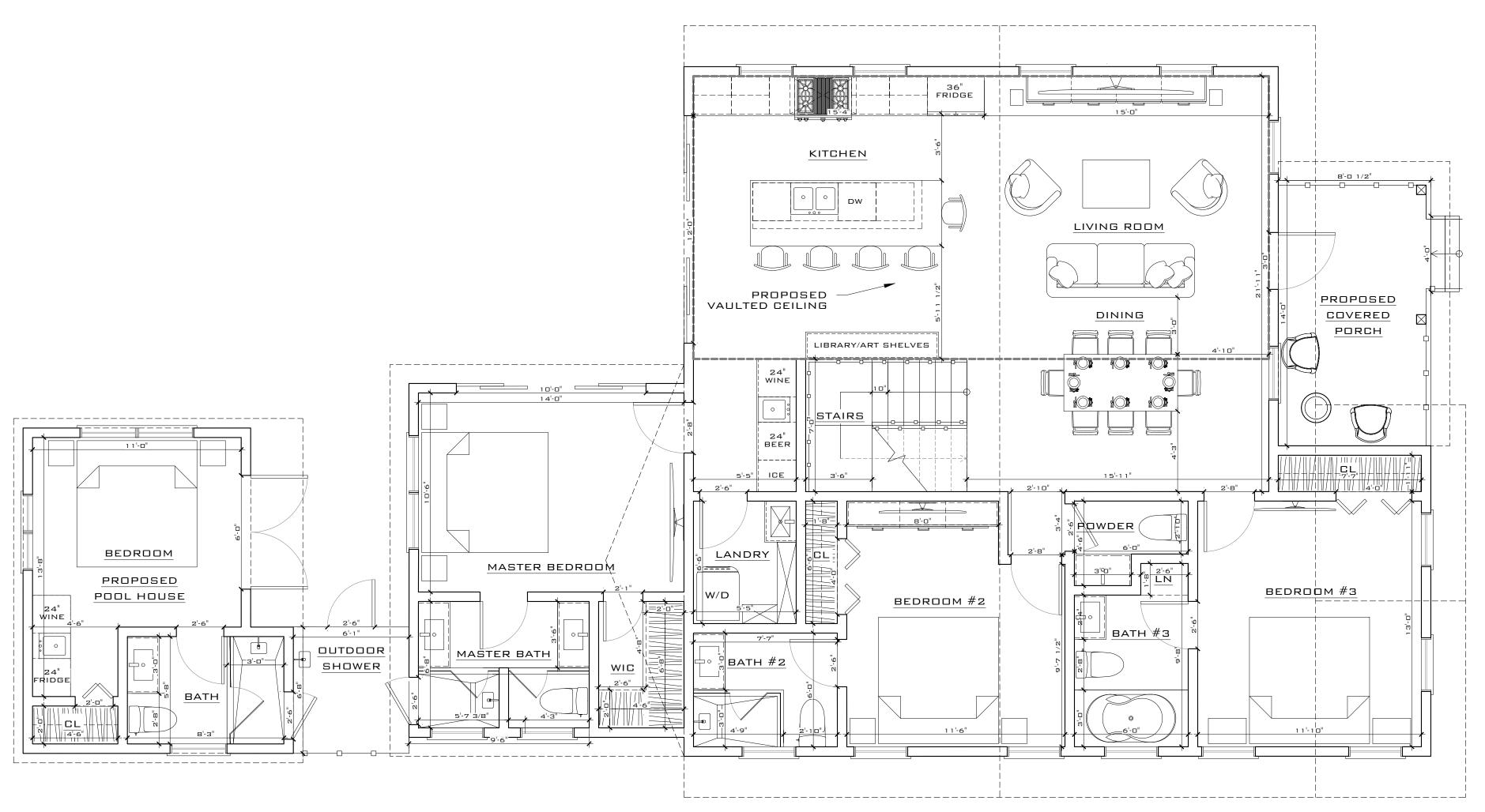

EXISTING FLOOR PLAN

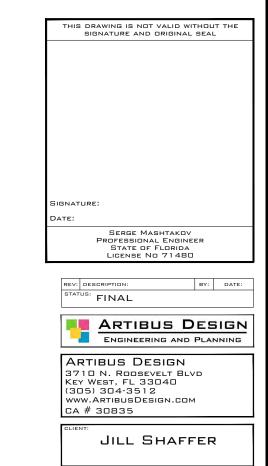


PROPOSED FLOOR PLAN (POOL HOUSE)

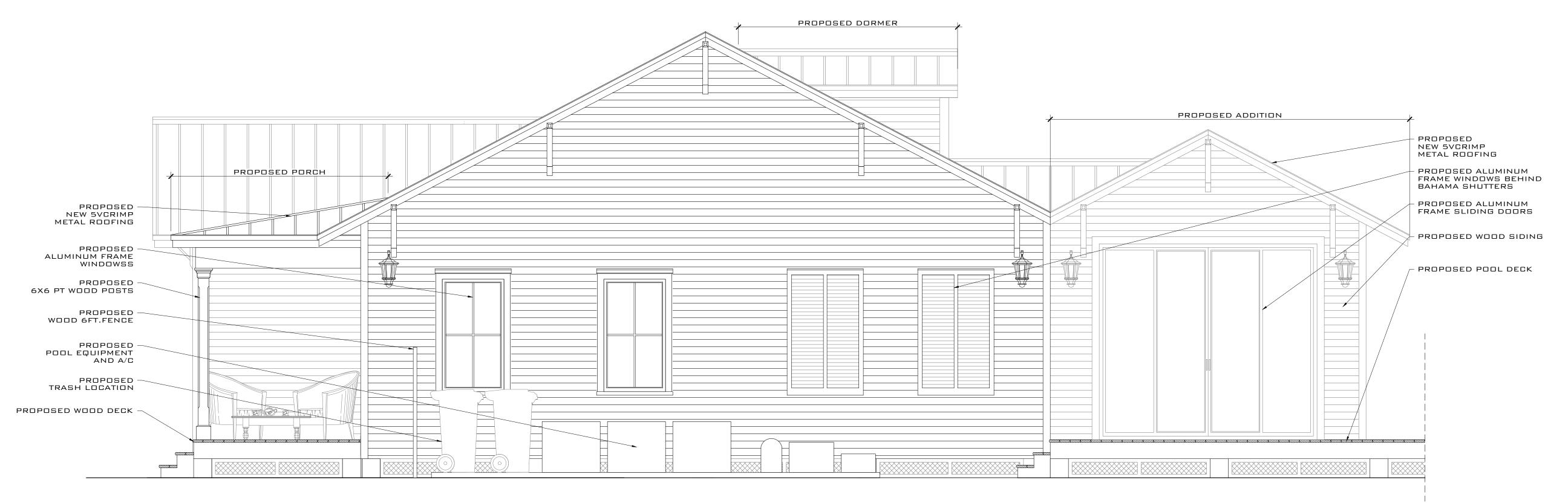






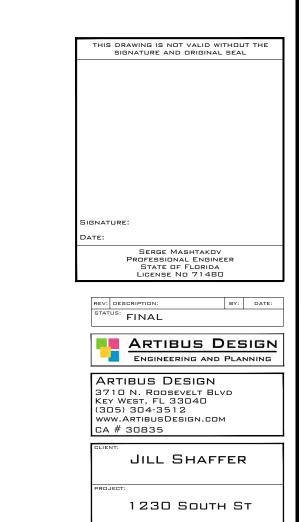
EXISTING RIGHT ELEVATION

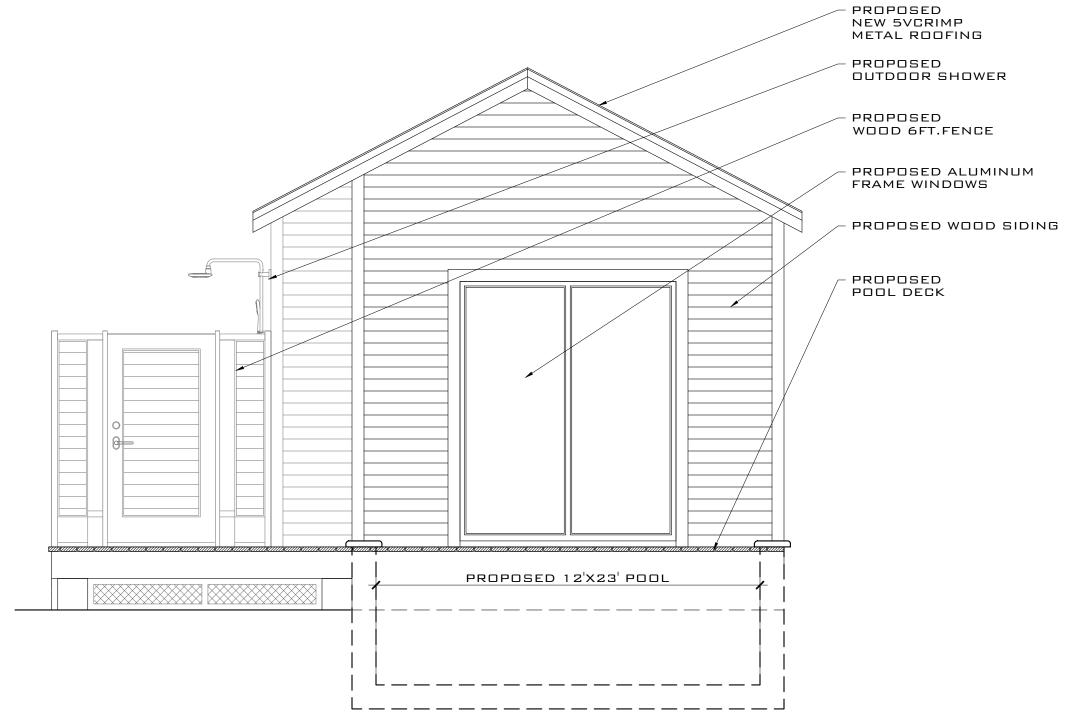


PROPOSED REAR ELEVATION (POOL HOUSE)

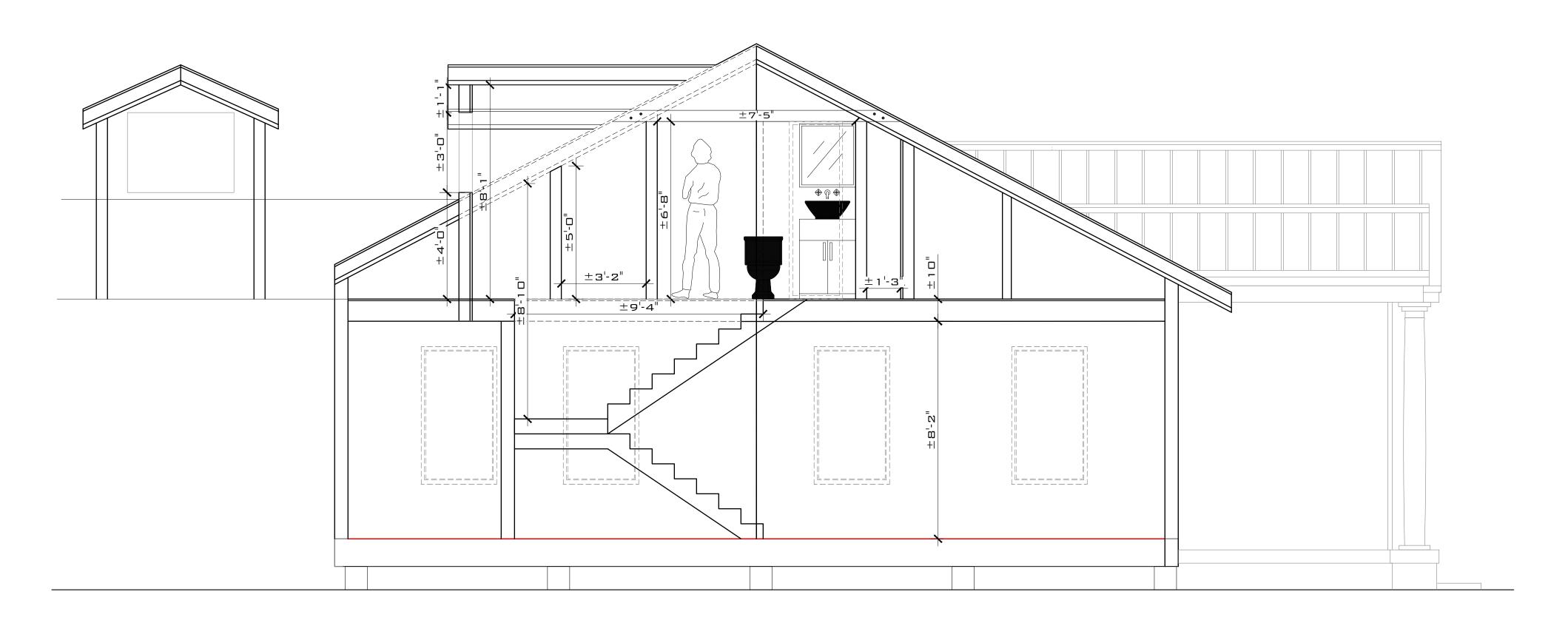






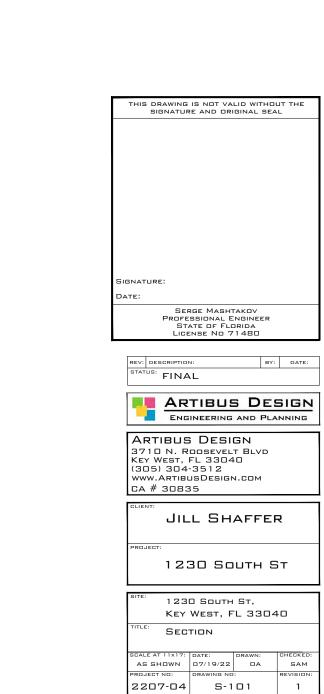
SECTION 1-1 BEDROOM

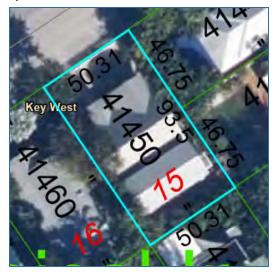
