

Formal grassed open areas were developed to stage public events. Extensive use of decorative paving, lighting, and site furniture were included to ensure a pedestrian-scaled project.

<u>Flagler Avenue Beachfront Promenade, City of New Smyrna Beach</u> - Project Manager. Beachfront park includes plaza with beach access, trellised promenade and covered shelter.

**Ed Smith Stadium Renovation, Baltimore Orioles** - Provided design services and construction documents for this Sarasota baseball complex consisting of the stadium, clubhouse and practice fields. Responsible for coordination of all site/sport field design including hardscape, landscape, lighting, site amenities and gold LEED certification. Fast tracked, brownfield project that required approvals from State, County and City authorities.

Emphasis was placed on "reconnecting" the downtown with the waterfront area. Featured were new plaza spaces for outdoor restaurant seating, art gallery display and casual seating. Other additions included new street trees and landscaping, period lighting, site furniture, and decorative sidewalks.

Sumter Boulevard Roadway Improvements, Phase I-III, City of North Port – Served as Landscape Architect for all three phases of this roadway improvement project. This interstate connector was widened to four lanes from U.S. 41 to I-75 and serves as the primary entryway into the City. Roadway design transitions from meandering rural section roadway near I-75 culminating in urban section roadway downtown. Design of thematic amenities included gateway entry features, recreational trails, street

lighting, shelters, bridges, noise walls and landscape elements. Required extensive public workshops to garner community support.

**SR 54 Corridor Study/Overlay Zone, Pasco County** - Worked with the Tampa Bay Regional Planning Council, Pasco County, FDOT District Seven, and local stakeholders to identify and recommend corridor enhancement alternatives associated with the widening of a nine-mile segment of SR 54. Corridor design recommendations addressed access and internal connectivity, individual site planning, roadway orientated signage, landscaping requirements, architectural requirements, and pedestrian/bicycle improvements. The study was incorporated into the Pasco County Land Development Code.

**Howard Street Streetscape, City of Live Oak** - Served as project manager on this streetscape redevelopment project in the historic downtown. Worked with the Regional Planning Council to secure grant funding for development and construction. Administered project through bidding and construction.

**North Sarasota Library, Sarasota County** - LEED Certified Gold project due in large part to site design, tree preservation, native landscape and micro-irrigation components provided as part of landscape architectural services. It was the first building in Sarasota County to achieve LEED status and the second library in the country to achieve Gold level designation. Design coordination allowed for preservation of several grand oak trees which dominate this library site. Involvement included close coordination with construction manager to ensure compliance with LEED requirements.

**Gateway Signage, City of Bradenton/Manatee County** - Provided signage concepts and construction documents for monument signage to serve as gateway for Bradenton/Manatee region. Worked closely with City and County officials to develop identity feature details and theme.

**Observation Tower and Environmental Trail, Historic Spanish Point, Osprey** - Developed concepts for an interpretive trail and tower system through this archaeologically significant and diverse coastal ecosystem. Tower design maximizes the views of the bay and barrier islands while being sensitive to its surroundings.

A four-acre lake with fountains was developed to serve as a focal point for the park. Located adjacent to Interstate 75, the park serves as the gateway to the Vineyards Development.

**Woodmere Park, Sarasota County** - Served as project manager on this thirty-five acre Sarasota County park that features an 11,000 square foot community center with a gymnasium, classrooms, offices, kitchen and an outdoor amphitheater/plaza. A central pedestrian spine connects the community center with tennis and basketball courts, a playground, and picnic areas. The City of Cocoa Waterfront Park was the first phase of a comprehensive revitalization plan for the City. The park consists of a linear boardwalk that extends one quarter of a mile along the inter-coastal waterway. The project was permitted through the State of Florida Department of Natural Resources and has become a signature project other cities on the east coast of Florida.

#### Lakewood Ranch Community Park - Manatee County, FL

Design of the first Community Park in the Lakewood Ranch Development located in Manatee County, Florida. The design features softball, soccer, tennis courts, basketball court, play structures and extensive landscaping.

#### Vineyards Community Park - Collier County, FL

Vineyards Community Park is a three million dollar park complex built around a scenic man-made three (3) acre lake located within the vineyards P.U.C. in Collier County Florida. **Veterans Memorial – Fort Pierce, FL –** Veterans Memorial Park in Fort Pierce went through multiple design charrettes with local Veteran organizations, City officials and the Public before reaching it's final character that ultimately pays tribute to the soldiers of this country. With a fountain as the central feature, black granite memorials, curvaceous seating walls and winding walkways radiate outwards. An amphitheatre covered by a space frame structure will seat up to 120 people for events, while the site also includes a restroom, large granite columns, waterfront pavilions, ceremonial urns, and dramatic landscaping.

#### **Conceptual Design**

**Wilton Manors Public Safety Complex – Wilton Manors, FL –** Design meetings with Wilton Manors city officials assisted in developing a fully integrated Site Master Plan for a Proposed City Hall and Public Safety Complex centrally located within the city. The final result was the combination of the City Hall and Police station with a plaza and conjoined parking, along with additional pedestrian walkways, playgrounds, ball courts and open lawns.

**Village Commons Park – Royal Palm Beach, FL –**The intent behind the design of this park was to establish a world-renowned active and passive park that would elevate the appeal of the Village to its residents and tourists alike. Along with a nine hole executive training golf course, there is a 20-acre lake system, Great Lawn, Community

Services area, Central Plaza, roughly 40 acres of wooded recreational land, botanical gardens, and room for an additional Community Arts School and Botanical Garden.

**Halpatiokee Preserve – Stuart, FL –** The Southern Addition of the Halpatiokee Preserve is to be an outdoor enthusiasts' dream. With the addition of new hiking and mountain biking trails, there will be shell parking, a rustic campsite, a solar powered nature center, the addition of littoral zones to the existing man-made lakes, and kayak and canoe launches. Located along the South Fork of the Saint Lucie River, adventurers can spend an entire weekend kayaking and mountain biking on the site.

**Veterans Park – Fort Pierce, FL –** The soul intention of the design of this park was to dedicate land to the Veterans of this nation while tackling existing issues and concerns on the site. With more development downtown and a lack of interconnectivity of city amenities, we designed a park that gives due respect to veterans and establishes all park amenities necessary for a true waterfront park that will eventually become part of the Fort Pierce greenways plan.

**Canopy Shores Park – St. Augustine, FL –** This 33 acre site is located along the Matanzas River and is one of the last parcels left in the St. Augustine Shores PUD. The enter park consists of dense hydric hammock and estuarine tidal marsh, so environmental sustainability was the main concern when adding new park amenities. Along with a raised boardwalk and canopy walk, there will be a centrally located area that will contain parking, a restroom, picnic shelters, playgrounds, an amphitheatre, and outdoor classroom.

**Lincoln Avenue Community and Recreation Park – Mount Dora, FL –** Mount Dora has a series of parks that are in need of renovation. RMPK initially established a Parks Master Plan before taking on the task of designing this intricate passive and active park. The entire site is located on roughly 80 acres of land, but certain parcels are zoned for separate grant monies. So the main task behind designing this park was to create a transition between what was to be active (baseball fields, water park, etc.), and what was to be passive. There was also a need for interconnectivity between the two schools located at separate ends of the park.

**Tropica Sands – Costa Rica –** Tropica Sands is a world-class resort in Costa Rica where RMPK was hired to design the hardscaping and landscaping for the entry drive and pool/ terrace area. Located on the beach, a beautifully tiered terrace with waterfalls and custom artwork was created as the grand entry. # project management

# **Management Approach**

Our approach to project management reflects our philosophy that a well-organized and coordinated project usually ensures a quality project, completed on time and within budget. Below are key components of our project management approach:

CalleVerde has past experience managing multidisciplinary teams on similar projects

Our Project Team utilizes state-of-the-art project management and reporting systems.

All key personnel are knowledgeable of key issues, county and state agency review, permitting and approval processes, and appropriate construction materials and methods.

Our project management philosophy is based upon a project team concept. Each member of the project team is selected based on their particular expertise and the unique needs of each project. This ensures continuity for each project phase, from the initial activities through implementation. For each project, a series of project organization sessions are undertaken with the client and project team members. This allows the client/consultant team to formulate a clear understanding of the project goals and objectives. From that point, a set of detailed strategies can be outlined to accomplish the agreed upon goals.

At the outset of the project, a work plan will be prepared outlining all work elements including scope, schedule, and budget for all participants. The plan will also address responsibilities, authority, communication, document control, invoicing, progress reporting, quality control, and other major work elements.

**Project Control:** The Team utilizes a computerized system for project planning, monitoring, and control. Project planning includes the establishment of project tasks and sub-tasks, the assignment of sufficient resources to accomplish those tasks, and the scheduling of tasks within the overall project time frame. Project monitoring reviews the current progress of the project and includes the assessment of budget and schedule status at any given point in time during execution of the project. In addition, software is utilized to develop a critical path for project deliverables, tracking both progress and costs to date. This system provides a clear record of activities and the ability to monitor and control project costs and schedule.

The project-planning phase generates a series of initialization reports to be used in evaluating the initial status of the project. The reports generated by this phase of the computer program are:

- Labor rate schedules
- Task costs
- Project schedule
- Project expenditures
- Labor resource requirements

During project monitoring, update reports are generated which indicate the current status of a particular project at a given point in time. These update reports include: The overall schedule status and the overall budget status. When managing a multiple consultant team, we require all consultant team members to provide-status reports twice each month. In return, the project manager reports back to each consultant twice a month with a project status memo, which informs each consultant of the others' progress and informs team members of project milestones and deliverable dates. On a monthly basis, the client receives a detailed progress report with each billing.

Monthly billings are developed for the client utilizing QuickBooks billing software. The monthly billing report provides detailed breakdowns of hours charged to the job by specific personnel and/or labor categories. The billing also provides a status summary, which covers expenditures-to-date (both direct and indirect) with percentage of completion.

Utilizing these project management techniques for monitoring the project budget and schedule, our Project Manager can quickly identify potential problems and introduce corrective measures. 
