Original Narrative By Adam Lashley, 10/25/25 01:55

On Saturday 10/25/25 at approximately 0043 hours, I (Ofc. Lashley) was working the 200 block of Duval St. for Fantasy Fest when I heard Ofc. Flores call out an incident occurring at 218 Duval St. (Teasers).

Upon my arrival, I observed numerous individuals surrounding Ofc. Flores and yelling at her. I positioned myself between her and a male subject later identified as Marcus Hosfield. I gave Marcus loud verbal commands to step back, which he refused to do. Multiple individuals continued trying to approach Ofc. Flores, so I extended my right arm and pushed Marcus back while again ordering him to step away. Marcus continued stepping toward me, directing his anger toward me, and took an aggressive posture. He yelled directly in my face, calling me a racist.

Sgt. Stutz arrived on scene to assist and gave Marcus lawful commands to step back. Marcus attempted to go around Sgt. Stutz, at which point Sgt. Stutz placed his hands on Marcus to prevent further escalation. Marcus then attempted to push Sgt. Stutz, at which time Sgt. Stutz took Marcus to the ground. I immediately placed handcuff restraints on Marcus and escorted him to 510 Greene St. (Old City Hall), where I turned him over to Monroe County Correctional Deputies for transport to the Monroe County Detention Center.

It should be noted that Marcus stated that he was wrong and he overreacted in the situation.

Marcus sustained a minor abrasion to his elbow and declined medical treatment.

See Sgt. Stutz's supplemental report for additional details.

Based on my investigation, I find probable cause to believe that on 10/25/2025, Marcus Hosfield did knowingly and willfully resist, obstruct, or oppose law enforcement officers, specifically Ofc. Lashley and Sgt. Stutz, while they were engaged in the lawful execution of their legal duties, by refusing lawful verbal commands, taking an aggressive posture, and physically attempting to push Sgt. Stutz.

Supplemental Narrative By Thomas Stutz, 10/25/25 03:20

On Saturday, October 25, 2025, at approximately 0043 Hours, I (Sgt. Stutz) was working the FantasyFest Street Fair Detail, wearing my full Class-B Uniform, stationed at the intersection of Caroline St. and Duval St. Both Ofc. Lashley and I heard Ofc. Flores advise over the radio that she had a physical disturbance in front of 218 Duval St., Teasers.

Both Ofc. Lashley and I responded to the area on foot and observed that Ofc. Flores was surrounded by four to six males that were screaming at her as she attempted to conduct her investigation. I observed Ofc. Lashley placed himself between Ofc. Flores and the males and gave them loud verbal commands to step back. One of the males, later identified as Marcus Hosfield, refused to move back and pushed forward toward Ofc. Lashley. I observed as Ofc. Lashley re-directed Hasfield by pushing him away and again giving loud verbal commands to step back. As I approached, I heard Hosfield screaming at Ofc. Lashley calling him a "Racist". Hosfield continued to call Ofc. Lashley a racist and again began moving toward him. I stepped between Hosfield and Ofc. Lashley and gave him loud verbal commands to step back and leave the area so Ofc. Lashley could redirect his attention back to the group around Ofc. Flores. Hosfield began to step back but then tensed his arms, clenched his fists and attempted to walk past me to my right, in an attempt to re-engage with Ofc. Lashley. I stopped Hosfields advance and pushed him backwards, again giving loud verbal commands for him to leave the area. Hosfield then tried to pass me on my right. When I stopped his advance again he attempted to push off me. I then grabbed Hosfield around his body and redirected him to the ground with a modified hip toss.

Once on the ground I advised Hosfield to stop resisting and that this incident was over. Hosfield became compliant and was handcuffed by Ofc. Lashley who arrived to assist. Ofc. Lashley and I the escorted Hosfield to the Monroe County

Detention Center Processing Center staged at 510 Greene St.

While being processed, Hosfield made repeated statements about letting his emotions take over and that he made a mistake by not listening to officers. I spoke to Hosfield briefly to gather his information and observed he had a small abrasion on his right elbow. I photographed the injury and provided the photographs to Sgt. M. del Valle who responded to complete a response to resistance report for this incident.

Ofc. Lashley completed the arrest and Hosfield was transported to Monroe County Detention Center for processing by Corrections Staff.

My BWC was actiavted for this incident and entered into evidence.com.
