A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA APPROVING ONE (1) POLICY-YEAR RENEWAL TO THE CITY'S CURRENT AGREEMENT WITH RELATION INSURANCE SERVICES OF FLORIDA, INC. TO PROVIDE THIRD PARTY CLAIMS ADMINISTRATION SERVICES FOR POLICY YEAR 2025/2026 (10/1/2025-9/30/2026) PURSUANT TO SECTION V. OF THE CURRENT AGREEMENT WHICH PROVIDES THE CITY THE OPTION TO EXERCISE TWO (2) ONE (1) POLICY-YEAR RENEWALS; AUTHORIZING THE CITY MANAGER TO EXECUTE ALL NECESSARY RELATED DOCUMENTS AND BUDGET TRANSFERS/APPROVALS, WITH THE APPROVAL OF THE CITY ATTORNEY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on September 20, 2022, pursuant to the City's Request for Proposals for Third Party Claims Administration Services (RFP 22-004) and the recommendation of the RFP Evaluation Committee, the City Commission adopted Resolution No. 22-206 authorizing the City Manager to enter into an agreement with Relation Insurance Services of Florida, Inc. for a three (3) policy-year term beginning 10/1/2022 through 9/30/2025 to include the option for the City to exercise up to two (2) one (1) policy-year renewals, pursuant to City RFP 22-004; and

WHEREAS, staff recommends the City exercise the first one (1) policy-year renewal option authorizing Relation Insurance Services of Florida, Inc. to continue to provide Third Party Claims Administration Services to the City for Policy Year 2025/2026 (10/1/2025 - 9/30/2026); and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION
OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the City Commission hereby approves the one
(1) policy-year renewal of the City's Agreement with Relation
Insurance Services of Florida, Inc. to continue to provide Third
Party Claims Administration Services for Policy Year 2025/2026
(10/1/2025 - 9/30/2026).

Section 2. That adequate funds are available in Accounts
502-1952-519-3100 (Liability Insurance) and 502-1953-519-3100
(Workers Compensation) of the proposed FY 2025/2026 Risk
Management Budget, once approved, for Policy-Year Term 2025/2026
(10/1/2025-9/30/2026) in the amount of up to \$45,000.00.
Compensation is based on a flat fee, per-claim basis. Based on
historic experience, it is anticipated the annual fees for
Policy Year 2025/2026 will not exceed \$45,000 for services
rendered.

Section 3: The City Manager is hereby authorized to
execute any necessary related documents and budget
transfers/adjustments, with the consent of the City Attorney.

Section 4: That this Resolution shall go into effect
immediately upon its passage and adoption and authentication by
the signature of the Presiding Officer and the Clerk of the
Commission.
