

RESOLUTION NO. 21-269

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A PURCHASE FROM TEN-8 FIRE & SAFETY, LLC IN AN AMOUNT NOT TO EXCEED \$1,837,447.65 (WITH OPTIONAL PRE-PAYMENT DISCOUNT) INCLUDING THE PURCHASE OF ONE 2023 PIERCE IMPEL 107' AERIAL APPARATUS WITH ASSOCIATED OPTIONS AND EQUIPMENT (\$1,082,739.00), ONE 2023 PIERCE IMPEL PUMPER APPARATUS WITH ASSOCIATED OPTIONS AND EQUIPMENT (\$672,408.00) AND ADDITIONAL NECESSARY FIREFIGHTING/EMERGENCY EQUIPMENT (\$82,300.65), PURSUANT TO GOVERNMENT CONTRACT, SECTION 2-797(3) OF THE CODE OF ORDINANCES; AUTHORIZING NECESSARY BUDGET TRANSFERS OR ADJUSTMENTS; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE NECESSARY DOCUMENTS UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Fire Department administrative staff has recommended the purchase of a fire aerial apparatus, pumper apparatus and associated options and equipment (\$1,755,147.00) from Ten-8 Fire & Safety, LLC, under the Florida Sheriff's Association (FSA) Bid No. FSA 20-VEF 14.02 for fire rescue vehicles and other equipment, pursuant to section 2-797(3) of the Code of Ordinances; and

WHEREAS, Fire Department administrative staff has recommended the purchase of necessary firefighting/emergency equipment and appliances (\$82,300.00) from Ten-8 Fire and Safety, LLC, under Lake County Florida Contract Number 17-0606L for Fire Equipment, Pars, Supplies and Service; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That a purchase from Ten-8 Fire & Safety, LLC in an amount not to exceed \$1,837,447.65 (including optional pre-pay discount), of one 2023 Pierce Impel 107' Aerial Apparatus with associated options and equipment (\$1,082,739.00), one 2023 Pierce Impel Pumper Apparatus with associated options and equipment (\$672,408.00), and additional necessary equipment (\$82,300.65), is hereby approved, pursuant to Section 2-797(3) of the code of ordinances.

Section 2: That funds in the amount of \$1,800,000.00 are budgeted for this acquisition and allocated in FY 21/22 Fire Department Infrastructure Fund under Budget account 101-2201-522-6400. Necessary budget transfers and adjustments from Infrastructure Surtax Fund reserves account 101-2201-522-9803, in the amount of \$37,447.65 are hereby authorized.

Section 3: That the City Manager or designee is authorized to execute necessary documents related to this purchase upon advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.



**Action Statement:**

Authorize the purchase of (1) 2023 Pierce Impel 107' aerial apparatus at the cost of \$1,082,739 and (1) 2023 Pierce Impel pumper apparatus at the cost of \$672,408 with all necessary options and accessories, at the cost of \$1,755,147, utilizing the Florida Sheriffs Association Contract FSA20-VEF14.02, Fire Rescue Vehicles and Other Equipment and all necessary firefighting equipment and appliances at the cost of \$82,300, utilizing the Lake County, Florida Contract Number 17-0606L for Fire Equipment, Parts, Supplies, and Service from Ten-8 Fire and Safety for a total pre-payment cost of \$1,837,447, pursuant to the terms of City of Key West Ordinance Section 2-797(3) purchases and acquisitions under contracts of the federal government and the state or its political subdivisions.

**Background:**

The Key West Fire Department is budgeted \$1,800,000 this fiscal year (FY21/22) to purchase (1) new 107' aerial apparatus to replace Ladder 1, our current frontline 2007 75' Pierce aerial, and (1) new pumper apparatus to replace Engine 4, a reserve 2004 Pierce pumper. To meet the specific needs of the fire department, the quoted cost of these vehicles includes necessary options and emergency equipment to be supplied and installed by Ten-8 Fire and Safety, per the FSA20-VEF14.02 and Lake County 17-0606L awarded contracts.

The Florida Sheriffs Association Cooperative Purchasing Program (FSA) has followed the attached Contract Terms and Conditions to procure this contract for fire apparatus. The FSA and Lake County contracts offer extended and guaranteed prices to any local government or political subdivision of the state, public educational institutions, other public agencies or authorities with the State of Florida, and other entities approved by the manufacturer participate in these contracts. Piggybacking off these awarded contracts provides a price level that Key West could not achieve by purchasing these apparatus and equipment independently.

After diligent review, staff has determined that this Pierce fire apparatus and equipment purchase offered by Ten-8 Fire and Safety is fair and reasonable in terms of pricing and a 17-month delivery

estimate. Although Pierce is not the least expensive fire apparatus builder, they are not the most expensive, representing a good balance of proven quality and price.

### **Purpose and Justification:**

This purchase will provide modern, reliable fire apparatus that will continue our goal of a standardized fleet to safely respond to emergency calls for service and realign our department following the goals outlined in the fleet replacement schedule of our strategic plan based on National Fire Protection Agency recommendations for fire apparatus. Rising costs for production and limited availability of supplies and materials are expected to continue. Any delay in replacing our current 2004 pumper and 2007 aerial will likely increase apparatus repair and maintenance costs and future replacement costs.

### **Financial Impact:**

A total amount of \$1,800,000 is budgeted in the Fire Department Infrastructure Surtax Fund, 101-2201-522-6400 for Fiscal Year 2021-22. The total cost of this purchase utilizing the optional pre-payment discount (aerial -\$33,108, pumper -\$19,843) is \$1,837,447, leaving a funding deficit of \$37,447 which will be covered using Infrastructure Surtax Fund reserves, 101-2201-522-9803.

### **Recommendations:**

Authorize the purchase of (1) 2023 Pierce Impel 107' aerial apparatus at a pre-payment cost of \$1,082,739 and (1) 2023 Pierce Impel pumper apparatus at a pre-payment cost of \$672,408 with all necessary options and accessories, at the cost of \$1,755,147, utilizing the FSAC contract FSA20-VEF14.02, and all necessary firefighting equipment and appliances at the cost of \$82,300, utilizing the Lake County, Florida Contract Number 17-0606L from Ten-8 Fire and Safety for a total pre-payment cost of \$1,837,447, pursuant to City of Key West Ordinance Section 2-797(3) purchases and acquisitions under contracts of the federal government and the state or its political subdivisions.
