As you are aware, the city code enforcement division approached me June 24<sup>th,</sup> 2009, with the necessity of removing the wall from around my property. With a limited amount of time to comply, and limited assets, we had difficulty meeting the deadline of August 24<sup>th,</sup> 2009, or 60 days that was given to us by the city.

We had to locate a licensed contractor who could do the job that the city required and come up with enough money as a down payment. Within the 60 days we contracted with J.J. Fairbanks Contractors for the amount of \$19,478.20 and gave him a \$6000.00 deposit and had him pull the necessary permit. All work was completed and the lien cleared by October 14<sup>th</sup>, 2009. I am sure that if I had showed you the contract and asked you for the necessary additional time to complete the job you would have granted it to me. As I had already hired a contractor and all permits were already obtained, I did not know it would be necessary.

With this economy we have endured many problems. We are currently two years behind in the real estate taxes and still owe the contractor a small balance for the removal of the wall.

We did our best to comply with the deadline but we just could not meet it. We did comply with everything that the city wanted us to do, and are now asking the City to waive this fine.

We appreciate your cooperation in this matter.
