SECTION 2. That Mote Marine Laboratory, Inc. is hereby granted permission the use of the Truman Waterfront property next to the Eco-Discovery building at 38 E Quay Road.

SECTION 3. That the Mote Marine Laboratory, Inc. will submit to the City of Key West a user fee payment of \$500.00 and a deposit of \$1,000.00 for any damage risen out of the event at the Truman Waterfront.
