Furnish and install the following scopes of work:

Add Security Cameras and Mag Lock

Furnish and install a complete Magnetic Locking System for the Elevator Lobby Door per the following:

- -(1) maglock
- -(2) push to exit buttons
- -(1) motion detector
- -(1) switch for door modes
- -(2) 16/2 circuits from Check-in/Control to the elevator lobby door
- -(1) 24v power supply with battery backup

Furnish and install a complete Avigilon Camera System per the below listed devices, quantities, and attached layout drawings.

- 1. (8) 5MP H6M indoor mini dome IR cameras.
- 2. (1) 5MP H6SL indoor IR dome camera.
- 3. (1) 5MP H5A dual head outdoor camera.
- 4. (2) H5A multi-sensor 20MP cameras.
- 5. (2) Multi-sensor accessories.
- 6. (8) 5MP H6SL bullet cameras.
- 7. (2) remote monitoring workstation.
- 8. (7) 12MP H5A fisheye IR dome cameras.
- 9. (1) AINVR2-STD-FORM-D-32TB-NA (recorder).
- 10. (27) ACC7 enterprise camera channel (lifetime licenses).
- 11. (1) rack cabinet 27U deep server rack.
- 12. (1) equipment for rack cabinet with vents, shelves, and patch panels.
- 13. (2) 32" monitors for monitoring stations.
- 14. (30) CAT. 6 circuits for cameras/stations.
- 15. (1) TL-SG3452P 48Port PoE switch.
- 16. (1) APC APSMC15002UC (battery backup).
- 17. Programming, testing, and customer training.

Excludes permit costs

Provide credit for Alternate No. 1 Covered Walkway with Solar Panel Array System. The City has decided not to proceed with this work.

Revise fire extinguisher and cabinet package to include fourteen (14) surface mounted cabinets SS2409-SM Full Glass Door with Larsen LOC and Tagged MP 10 Extinguishers. Includes credit of two (2) semi recessed cabinets originally specified.





Provide BDA Rough-in and Testing

Provide electrical rough-in and testing of BDA system design per Pro-Tech BDA System plans dated 7.25.24. Work includes:

- 1. Provide and install (3) 16x16x4 junction boxes on ground level, interconnected with 2" EMT.
- 2. Provide and install 2" EMT from ground floor, penetrate to 1st floor electrical room to another 16x16x4 junction box.
- 3. Provide and install 2" EMT conduit interconnecting (3) 16x16x4 junction boxes above ceiling.
- 4. Provide and install 2" RMC from 1st floor electrical room through rough for future antenna.
- 5. Provide BDA testing and formal report findings, determining if a complete BDA System is required.

EXCLUSIONS

- 1. Permit costs.
- 2. Private Inspector costs.
- 3. BDA System/trim out.

Remove and Replace Tree for Keys Energy

Remove fishtail palm that is in conflict with the trench for Keys Energy underground electric work and provide a replacement to be planted within 500' of the current location. Please note that only initial watering during planting will be provided and any additional watering will be required to be performed by City or County personnel. The replacement palm will not be the exact same size as the palm being removed. It'll be about 2/3 of the height and 1/4 of the width. It'll grow in, but it's not possible to purchase a tree as mature as what is existing. Please also note that no warranty is provided on this new palm due to our landscape contractor not being contracted to provide watering.

Add Cellular Dialer to Elevator and Fire Alarm

Provide cellular dialer in elevator and fire alarm. Please note this is for the equipment only and the City of Key West will be responsible for signing up for and paying monthly recurring charges and monitoring agreements.

Add Flushometer Access Panels at Women's Bathroom

Furnish and install three (3) flush valve access panels model number Dura Ware 2898 in Women's bathroom.

Provide Circuit for Lighted Entrance Sign

Provide dedicated circuit for lighted exterior sign.
