A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF ONE 2023 FORD F-250 TRUCK WITH LIFTGATE (\$52,689.00) AND ONE FORD F-350 CRANE TRUCK (\$96,733.00) IN A TOTAL AMOUNT NOT TO EXCEED \$149,422.00 FROM DUVAL FORD LLC, THROUGH THE FLORIDA SHERIFF'S ASSOCIATION AND FLORIDA ASSOCIATION OF COUNTIES BID NO. FSA22-VEL30.0 and FSA22-VEH20.0 CONTRACTS, PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES FOR USE BY THE SANITARY SEWER UTILITY; AUTHORIZING NECESSARY BUDGET TRANSFERS OR ADJUSTMENTS; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE NECESSARY DOCUMENTS, UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, this purchase will be made under the Florida Sheriffs Association and Florida Association of Counties Bid No. FSA22-VEL30.0 and FSA22-VEH20.0 Contracts, pursuant to section 2-797(3) of the Code of Ordinances.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of one 2023 Ford F250 Truck with liftgate and related accessories (\$52,689.00) and one Ford F-350 Crane Truck with related accessories (96,733.00), as described in the attached proposals of Duval Ford LLC, pursuant to section 2-797(3) of the Code of Ordinances, under the Florida Sheriff's Association and Florida Association of Counties FSA22-VEL30.0 and FSA22-VEH20.0 Contracts, in a total amount not to exceed \$149,422.00, is hereby authorized for purchase and use by the Sanitary Sewer Utility.

Section 2: That funds in the amount of \$145,000.00 for this purchase are budgeted in Sewer/Treatment Plant Operations/Machinery Account No. 401-3504-535-6400. A transfer of \$4,422.00 is hereby authorized from Sewer Operating Account 401-3501-535-9803. Any necessary budget transfers or adjustments are hereby authorized.

Section 3: That the City Manager or designee is authorized to execute any necessary documents, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
