Jay, here are the answers to your questions. Sorry for the confusion.

1) On page 2, line 6 and 7 of the Residential Collection Services of the Price Form, the monthly totals for line 6 and 7 appear to be calculated in error. Please confirm the totals should be \$33,551.94 for line 6, and \$34,506.67 for line 7. In other words, should lines 6 and 7 be the same as lines 2 and 3 from this form? The answer to this question is YES, lines 6 and 7 should be the same as lines 2 and 3. There was a rounding error in the per unit prices on line 6 and 7. Net impact is \$8.18.

#### Resources

As specified in Section 4.1(I), Bidder shall demonstrate sufficient resources to provide the collection services required for the term of the Contract by supplying a list with the estimated number of routes anticipated to provide Residential Collection Service, the estimated number of homes per route, service vehicles to be used (including type of vehicle, make, model, and year), and personnel needed to service the routes.
