Underground Conduits for Future Generator per attached sketch

- Furnish and install (3) 3" PVC conduits from MTS on 2nd floor to future generator location and cap conduits on both sides.
- Furnish and install (1) 2" PVC conduit from MTS on 2nd floor to future generator location and cap conduits on both sides.

Revise interior electrical in areas where ACT was removed due to ceiling conflicts with concrete structure and ductwork. Includes five (5) new suspended linear light fixtures in lieu of lay-in fixtures, revised fire alarm and data wiring as required.
