**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING HOSPICE OF FLORIDA KEYS, INC. TO CONDUCT THE QUEEN MOTHER PAGEANT ON MONDAY, MAY 11, 2015 AT LA TE DA 1125 DUVAL STREET FROM 12:00 NOON TO 11:00 P.M.; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE CLOSURE OF THE 1100 BLOCK OF DUVAL STREET FROM 12:00 NOON TO 11:00 P.M.; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 8:00 P.M. TO 10:45 P.M (SOUND CHECK AT 4:00 P.M. TO 5:00 P.M); AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Hospice of Florida Keys, Inc. wishes to conduct the Queen Mother Pageant as a fundraiser for Hospice/VA & One Human Family Educational Foundation, Inc.; and

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West, Florida;

**SECTION 1.** That Hospice of Florida Keys, Inc. is hereby granted permission to conduct a Queen Mother Pageant on the day and during the hours stated above; **PROVIDED** that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meets the terms and conditions set forth by the City Manager.

**SECTION 2.** That Hospice of Florida Keys, Inc. is hereby granted permission for the closure of the 1100 block of Duval from 12:00 noon to 11:00 P.M., provided, however, that the special event shall end at 10:45 P..M. and the street may be closed until midnight while the stage is dismantled.

**SECTION 3.** That Hospice of Florida Keys, Inc. is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

**SECTION 4.** That pursuant to Section 18-86 of the Key West Code of Ordinances, Hospice of Florida Keys, Inc. is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

**SECTION 5.** Hospice of Florida Keys, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

**SECTION 6.** This Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
