**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING MOTE MARINE LABORATORY, INC. TO CONDUCT A "FLORIDA KEYS OCEAN FESTIVAL" AT THE TRUMAN WATERFRONT GRASSY AREA BY THE SPLASH PAD ON SUNDAY, DECEMBER 3, 2023, FROM 10:00 A.M. TO 3:00 P.M ; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE BARRICADED AREA; PROVIDING FOR AN EFFECTIVE DATE**

**NOW THEREFORE, BE IT RESOLVED**, by the City Commission of the City of Key West, Florida.

**SECTION 1.** That In Resolution 19-174, the City Commission directed the City Manager to “develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law.”

**SECTION 2.** “That the vendor/lessee/licensee acknowledges the City’s concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and “to go” packages for food or products sold on any property leased from the City.”

**SECTION 3.** That Mote Marine Laboratory, Inc. is hereby granted permission to conduct a "Florida Keys Ocean Festival" on the days and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the city is executed; provided the organization meet the terms and conditions set forth by the City Manager.

That 100% will be donated to the Mote Marine Laboratory, Inc.

**SECTION 4.** That Mote Marine Laboratory, Inc. is hereby granted permission the use of the Truman Waterfront grassy area next to the splash pad.

**SECTION 5.** That the Mote Marine Laboratory, Inc. will submit to the City of Key West a rental fee of \$500.00.

**SECTION 6.** That pursuant to Section 18-86 of the Key West Code of Ordinances, permission is granted to allow the sale and consumption of alcoholic beverages within the enclosed area.

**SECTION 7.** That Mote Marine Laboratory, Inc. must post the required notice regarding prohibition of purchase and sale of alcoholic beverages to persons under 21 years of age.

**SECTION 8.** That Mote Marine Laboratory, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

**SECTION 9.** That this resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
