The Bidder further declares that he has carefully examined the Contract Documents for the construction of the project, that he has personally inspected the site, that he has satisfied himself as to the quantities involved, including materials and equipment, and conditions of work involved, including the fact that the description of the quantities of work and materials, as included herein, is brief and is intended only to indicate the general nature of the work and to identify the said quantities with the detailed requirements of the Contract Documents, and that this Proposal is made according to the provisions and under the terms of the Contract Documents, which Documents are hereby made a part of this Proposal.

CONTRACT EXECUTION AND BONDS

LIQUIDATED DAMAGES

In the event the Bidder is awarded the Contract and shall fail to complete the work within the time limit or extended time limit agreed upon, as more particularly set forth in the Contract Documents, liquidated damages shall be paid to the Owner at the rate of \$1,000.00 per day for all work awarded until the work has been satisfactorily completed as provided by the Contract Documents. Sundays and legal holidays shall be excluded in determining days in default.

ITB Questions Submitted

1. We attended the pre bid for this project and intend to bid the work but I'm a little confused by some of the requirements and forms. One of the forms was a Local Vendor Form that states the contractor must be within 30 miles of the boundaries of the city. Did I read that correct? Our branch is in Ft. Lauderdale but not within 30 miles.

Yes, to receive local vendor preference you must live within 30 miles of Key West.

2. "The Bidder shall furnish documentation showing that he is in compliance with the licensing requirements of the provisions of Chapter 66 Section 87 of the Code of Ordinances of the City of Key West; within 10 days the following the Notice of Award and must demonstrate that he holds at a minimum, the following licenses & certificates;

A. City of Key West Business Tax License Receipt

B. A valid Certificate of Competency issued by the Chief Building Official of Key West, Florida."

We are a Certified State License Roofing Contractors and our Local Business Tax Receipt is from Miami Dade County. Please clarify if the above requirement applies or only the License Contractor requirement applies.
