AUTHORIZING RACE WORLD OFFSHORE, LLC TO CONDUCT A ROLLING STREET CLOSURE FOR A PARADE ON SUNDAY, NOVEMBER 2, 2025 AT 4:00 P.M., A STREET CLOSURE ON GREENE STREET FROM DUVAL TO ANN STREET ON THURSDAY, NOVEMBER 6, 2025, FROM 6:00 P.M. TO 10:00 P.M., A STREET CLOSURE FROM FRONT STREET TO SOUTHARD STREET AND FITZPATRICK TO SIMONTON STREET ON FRIDAY, NOVEMBER 7, 2025, FROM 6:00 P.M. TO 10:00 P.M, A CONCERT ON SATURDAY, NOVEMBER 8, 2025, FROM 11:00 A.M. TO 10:00 P.M. AT THE TRUMAN WATERFRONT COFFEE BUTLER AMPHITHEATER AND AN AWARDS CEREMONY ON SUNDAY, NOVEMBER 9, 2025, FROM 3:00 P.M. 10:00 P.M. AT THE TRUMAN WATERFRONT COFFEE BUTLER AMPHITHEATER; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE BARRICADED AREA DURING EACH EVENT; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Race World Offshore, LLC submitted an application for the Special Events to include a rolling street closure for a parade on Sunday, November 2, 2025 at 4:00 p.m., a street closure for a street party on Greene Street from Duval Street and Ann Street on Thursday, November 6, 2025, from 6:00 p.m. to 10:00 p.m., a street closure for a block party on Duval Street from Front Street to Southard Street and Greene Street from Fitzpatrick to Simonton Street on Friday, November 7, 2025, from 6:00 p.m. to 10:00 p.m., a Concert at the Coffee Butler Amphitheater on Saturday, November 8, 2025, from 11:00 a.m. to 10:00 p.m. and an awards ceremony at the Coffee Butler Amphitheater on Sunday, November 9, 2024, from 3:00 p.m. to 10:00 p.m.

WHEREAS, there will be no cooking and no generators during the street closures.

WHEREAS, the Coffee Butler Amphitheater will have the event catered.

WHEREAS, the street closure is a display of boats and foot traffic throughout the event.

WHEREAS, the Race World Offshore, LLC has agreed to abide by City Codes and Ordinances, including providing insurance.

NOW THEREFORE, BE IT RESOLVED, BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA

SECTION 1. That in Resolution 19-174, the City Commission directed the city Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law."

SECTION 2. "That the vendor/lessee/licensee acknowledges the City's concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and "To go" packages for food or products sold on any property leased from the City."

SECTION 3. That Race World Offshore, LLC is hereby granted

permission to conduct numerous events on the days and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the city is executed; provided the organization meet the terms and conditions set forth by the City Manager.

SECTION 4. That Race World Offshore, LLC. is hereby granted permission the use of the "Truman Waterfront Coffee Butler Amphitheater".

SECTION 5. That Race World Offshore, LLC. will submit to the City of Key West a rental fee agreed upon the City Manager plus tax.

SECTION 6. That pursuant to Section 18-86 of the Key West Code of Ordinances, permission is granted to allow the sale and consumption of alcoholic beverages within the enclosed area.

SECTION 7. That Race World Offshore, LLC must post the required notice regarding prohibition of purchase and sale of alcoholic beverages to persons under 21 years of age.

SECTION 8. That Race World Offshore, LLC acknowledges that they are responsible for scheduling and payment to the Key West Police Department, the Key West Fire Department and Community Services.

SECTION 9. That Race World Offshore, LLC will adhere to the recycling plan of the City of Key West, that one (1) recycling

container for everyone (1) trash barrels will be used and that they will be placed side by side.

SECTION 10. That this resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
