**SUBJECT:** Approval of a task order in an amount not to exceed \$160,598.80 to Charley Toppino & Sons, Inc. for milling, paving, and curbing of the Indigenous Park Parking Lot

**ACTION STATEMENT:** Approving a task order under the City's General Utilities and Infrastructure Contract with Charley Toppino & Sons, Inc. in a total amount not to exceed \$160,598.80 for the milling, paving and curbing of the Indigenous Park Parking Lot; authorizing any necessary budget adjustments; authorizing City Manager or designee to execute documents upon consent of the City Attorney; providing for an effective date.

**BACKGROUND:** The milling, paving, and curbing is part of the City's Capital Improvement Plan and was approved by the City Commission for Fiscal Year 22-23.

Project to be awarded under the General Utilities & Infrastructure Services contract awarded to Charley Toppino & Sons, Inc. via Resolution 21-125.

**PURPOSE AND JUSTIFICATION:** The parking lot at Indigenous Park is in a state of disrepair and needs to be repaired. This will fix the parking lot and make it a safe and attractive area.

**STRATEGIC PLAN:** Milling, Paving, and Curbing of Indigenous Park Parking Lot is consistent with the Key West Forward Strategic Plan, Priority 3: Streets and Sidewalks.

**OPTIONS:**

1. Approve the task order, in an amount not to exceed \$160,598.80, to Charley Toppino & Sons, Inc. for the milling paving and curbing of the Indigenous Park Parking Lot.

2. Disapprove the task order, in an amount not to exceed \$160,598.80, to Charley Toppino & Sons, Inc. for the milling paving and curbing of the Indigenous Park Parking Lot.

*Key to the Caribbean - Average yearly temperature 77° F.*

**FINANCIAL IMPACT:**

Milling, Paving and Curbing of the Indigenous Park Parking Lot is funded under Infrastructure Surtax/Parks and Recreation/Infrastructure 101-7201-572-63 as part of a Capital Improvement Project totaling \$655,000.

**RECOMMENDATION:**

Staff recommends approval Option 1; Approve the task order, in an amount not to exceed \$160,598.80, to Charley Toppino & Sons, Inc. for the milling paving and curbing of the Indigenous Park Parking Lot.
