Dear Sheriff Ramsey:

The purpose of this letter is to request the second of two (2) – four (4) renewal periods available to the City of Key West per Section 13: Term of Agreement in the Interlocal Agreement between the Monroe County Sheriff's Office (MCSO) and the City of Key Department of Transportation (KWDoT) for shared use of the 800 MHz Radio System.

Section 13 references the original term of the agreement as May 1, 2005, through September 30, 2009. The first renewal period through September 13, 2013 was exercised on July 15, 2010 and is nearing completion. We are now submitting this letter of request for the second renewal period to your office in hopes of a favorable response.

We respectfully request renewal of the Shared Radio Use Agreement, as noted above, to extend the term another four (4) years or through September 13, 2017.
